ABOUT THIS INSPECTION

The purpose of this inspection is to assure government, parents and the public of the quality of childcare and, if applicable, of nursery education. The inspection was carried out under Part XA Children Act 1989 as introduced by the Care Standards Act 2000 and, where nursery education is provided, under Schedule 26 of the School Standards and Framework Act 1998.

This report details the main strengths and any areas for improvement identified during the inspection. The judgements included in the report are made in relation to the outcomes for children set out in the Children Act 2004; the National Standards for under 8s day care and childminding; and, where nursery education is provided, the *Curriculum guidance for the foundation stage*.

The report includes information on any complaints about the childcare provision which Ofsted has received since the last inspection or registration or 1 April 2004 whichever is the later.

THE QUALITY AND STANDARDS OF THE CARE

On the basis of the evidence collected on this inspection:

The quality and standards of the care are satisfactory. The registered person meets the National Standards for under 8s day care and childminding.

At the time of the inspection there were no children on roll. Ofsted judges that the provider remains suitable to provide care.

WHAT SORT OF SETTING IS IT?

The childminder registered in 2000. She lives with her family in Hayes, Middlesex. The whole of the flat is used for childminding and there is a fully enclosed communal garden for outside play.

The childminder is registered to care for a maximum of three children at any one time but there are currently no children on roll. The family has two cats.

No children on roll

When a provider does not have children on roll at the time of the inspection, inspection judgements are based on evidence gathered from discussions with the provider and an inspection of the premises, equipment and relevant documentation.

As there are no children on roll, the quality of the provision cannot be judged better than satisfactory because there is no reliable evidence on which to assess its impact on children.

THE EFFECTIVENESS OF THE PROVISION

Helping children to be healthy

The provision is satisfactory.

The childminder has a sound understanding of suitable procedures to promote children's good health, by ensuring that positive steps are taken to prevent the spread of infection and appropriate measures are put in place when children are ill.

The childminder has a sound understanding of suitable procedures to ensure that food and drink for children is adequate, properly prepared, nutritious and complies with dietary and religious requirements.

Protecting children from harm or neglect and helping them stay safe

The provision is satisfactory.

The premises are safe, secure and include the necessary facilities for children. The childminder demonstrates an awareness of how to ensure the environment is made welcoming to children.

The furniture, equipment and toys are safe and appropriate for the needs of children.

The childminder understands how to promote children's safety and take precautions to prevent accidents.

The childminder has an adequate knowledge of child protection procedures approved by the Local Safeguarding Children Board, and is aware of her responsibility to protect the welfare of the child.

Helping children achieve well and enjoy what they do

The provision is satisfactory.

The childminder has a satisfactory knowledge of how individual children develop and learn.

Helping children make a positive contribution

The provision is satisfactory.

The childminder has an appropriate knowledge and awareness of the importance of treating each child with equal respect and concern.

The childminder is aware that some children may have learning difficulties or disabilities, and understands the importance of working in partnership with parents and with other professionals to promote the welfare and development of the child.

The childminder shows a willingness and commitment to working with parents to manage children's behaviour in a consistent way which promotes the child's welfare and development.

The childminder has a satisfactory understanding of the need to develop a strong partnership with parents, taking into account their differing needs.

Organisation

The organisation is satisfactory.

The childminder is aware of the duty to ensure that other people living or working on the premises are suitable to be in contact with children.

The childminder understands the importance of working within the constraints of the condition of registration relating to number of children; and of organising space and resources to best meet the needs of the children.

The childminder has a sound awareness of the records to be kept and the importance of these.

Improvements since the last inspection

At the last inspection, the childminder received a recommendation to add to the resources which represent positive images of the diverse community we live in. The childminder utilises the local toy and book library resources and visits local places of interest in the community when she is minding. As there are currently no children on roll, there is no information available to assess the impact on children's development.

Complaints since the last inspection

Not applicable: the childminder has not cared for children since registration.

The provider is required to have procedures for dealing with concerns and complaints from parents and to keep a record of complaints and their outcome.

THE QUALITY AND STANDARDS OF THE CARE

On the basis of the evidence collected on this inspection:

The quality and standards of the care are satisfactory. The registered person meets the National Standards for under 8s day care and childminding.

At the time of the inspection there were no children on roll. Ofsted judges that the provider remains suitable to provide care.
