ABOUT THIS INSPECTION

The purpose of this inspection is to assure government, parents and the public of the quality of childcare and, if applicable, of nursery education. The inspection was carried out under Part XA Children Act 1989 as introduced by the Care Standards Act 2000 and, where nursery education is provided, under Schedule 26 of the School Standards and Framework Act 1998.

This report details the main strengths and any areas for improvement identified during the inspection. The judgements included in the report are made in relation to the outcomes for children set out in the Children Act 2004; the National Standards for under 8s day care and childminding; and, where nursery education is provided, the *Curriculum guidance for the foundation stage*.

The report includes information on any complaints about the childcare provision which Ofsted has received since the last inspection or registration or 1 April 2004 whichever is the later.

THE QUALITY AND STANDARDS OF THE CARE

On the basis of the evidence collected on this inspection:

The quality and standards of the care are inadequate – notice of action to improve. The registered person does not meet the National Standards for under 8s day care and childminding.

At the time of the inspection there were no children on roll. Ofsted judges that the provider remains suitable to provide care.

WHAT SORT OF SETTING IS IT?

The childminder has been registered since 1991. She lives in a house in a residential area of Norwich. The ground floor of her home is used for childminding with access to the upstairs toilet and bathroom. There is an enclosed garden for outside play. The childminder has a dog.

The childminder is registered to care for a maximum of six children at any one time but has not cared for children for several years.

No children on roll

When a provider does not have children on roll at the time of the inspection, inspection judgements are based on evidence gathered from discussions with the provider and an inspection of the premises, equipment and relevant documentation.

As there are no children on roll, the quality of the provision cannot be judged better than satisfactory because there is no reliable evidence on which to assess its impact on children.

THE EFFECTIVENESS OF THE PROVISION

Helping children to be healthy

The provision is satisfactory.

The childminder has a sound understanding of suitable procedures to:

- * promote children's good health, by ensuring that positive steps are taken to prevent the spread of infection and appropriate measures are put in place when children are ill. (National Standard 7: Health)
- * ensure that food and drink for children is adequate, properly prepared, nutritious and complies with dietary and religious requirements. (National Standard 8: Food and drink).

Protecting children from harm or neglect and helping them stay safe

The provision is inadequate.

- * The premises are not safe as the childminder has not taken precautions to prevent accidents particularly in respect of the safety of the upstairs, the stairs and the kitchen. This is because she has not been caring for children. (National Standard 6: Safety)
- * The premises are secure and include the necessary facilities for children. The childminder demonstrates an awareness of how to ensure the environment is made welcoming to children. (National Standard 4: Physical environment)
- * The furniture, equipment and toys are safe and appropriate for the needs of children. (National Standard 5: Equipment)
- * The childminder has a sound knowledge of child protection procedures approved by the Local Safeguarding Children Board, and is aware of her responsibility to protect the welfare of the child. (National Standard 13: Child Protection)

Helping children achieve well and enjoy what they do

The provision is satisfactory.

- * The childminder has a satisfactory knowledge of how individual children, develop and learn. (National Standard 3: Care, learning and play)

Helping children make a positive contribution

The provision is satisfactory.

The childminder:

- * has an appropriate knowledge and awareness of the importance of treating each child with equal respect and concern. (National Standard 9: Equal opportunities)
- * is aware that some children may have learning difficulties and/or disabilities, and understands the importance of working in partnership with parents and with other professionals to promote the welfare and development of the child. (National Standard 10: Special needs)

* shows a willingness and commitment to working with parents to manage children's behaviour in a consistent way which promotes the child's welfare and development. (National Standard 11: behaviour)

* has a satisfactory understanding of the need to develop a strong partnership with parents, taking into account their differing needs. (National Standard 12: Working in partnership with parents and carers)

Organisation

The organisation is inadequate.

The childminder:

* has not maintained a current first aid certificate. This means she lacks sufficient understanding of how to support children appropriately in the event of an accident or medical emergency. (National Standard 1: Suitable person)

* understands the importance of working within the constraints of the conditions of registration relating to numbers of children; and of organising space and resources to best meet the needs of the children. (National Standard 2: Organisation)

* has a sound awareness of the records to be kept and the importance of these. (National Standard 14: Documentation)

Improvements since the last inspection

At the last inspection the childminder was asked to complete an appropriate first aid course, complete a health check, ensure the premises are maintained in a suitable state of cleanliness/repair/decoration, make sure electrical sockets are protected, improve the safety in the kitchen and notify Ofsted of starting to care for children. The childminder has not completed a first aid course but is booked to attend one shortly. Consequently, this is raised as an action in this report. A health check is currently being processed and she has notified Ofsted of her intention to resume childminding. She is currently completing the decoration of her home but has not taken the required action to make sure it is safe and risks to children are minimised. This is because she has not been caring for children. This is raised as a further action in this report as she now intends to childmind.

Complaints since the last inspection

Since 1 April 2004 there have been no complaints made to Ofsted that required the provider or Ofsted to take any action in order to meet the National Standards.

The provider is required to keep a record of complaints made by parents, which they can see on request. The complaints record may contain complaints other than those made to Ofsted.

THE QUALITY AND STANDARDS OF THE CARE

On the basis of the evidence collected on this inspection:

The quality and standards of the care are inadequate - notice of action to improve. The registered person does not meet the National Standards for under 8s day care and childminding.

At the time of the inspection there were no children on roll. Ofsted judges that the provider remains suitable to provide care.

WHAT MUST BE DONE TO SECURE FUTURE IMPROVEMENT?

The quality and standards of the care

To improve the quality and standards of care, the registered person **must** take the following actions:

- complete a first aid course which includes training for infants and young children
- ensure that hazards to children on the premises are minimised. This particularly refers to the safety of upstairs, the stairs and the kitchen.

These actions are set out in a *notice of action to improve* and must be completed by the date specified in the notice.
