Introduction

This inspection was carried out by Ofsted under Sections 49 and 50 of the Childcare Act 2006 on the quality and standards of the registered early years provision. 'Early years provision' refers to provision regulated by Ofsted for children from birth to 31 August following their fifth birthday (the early years age group). The registered person must ensure that this provision complies with the statutory framework for children's learning, development and welfare, known as the *Early Years Foundation Stage*.

The report includes information on any complaints about the childcare provision which Ofsted has received since the last inspection or registration whichever is the later, which require Ofsted or the provider to take action in Annex C.

The provider must provide a copy of this report to all parents with children at the setting where reasonably practicable. The provider must provide a copy of the report to any other person who asks for one, but may charge a fee for this service (The Childcare (Inspection) Regulations 2008 regulations 9 and 10).

The setting also makes provision for children older than the early years age group which is registered on the voluntary and/or compulsory part(s) of the Childcare Register. This report does not include an evaluation of that provision, but a comment about compliance with the requirements of the Childcare Register is included in Annex B.

Description of the childminding

The childminder was registered in 2008. She lives with her partner and one child aged five in the village of Horsmonden. The whole of the ground floor and two bedrooms upstairs are used for childminding. There is an enclosed garden for outdoor play.

The childminder is registered to care for a maximum of five children on the Early Years register and the compulsory Childcare register. She is also registered on the voluntary Childcare register. She is currently minding four children in the early years age range and two children on the compulsory Childcare and one on the voluntary Childcare register. The family do not have any pets.

The childminder has the Nursery Nursing Examination Board (NNEB) Certificate in Nursery Nursing obtained in June 1989.

Overall effectiveness of the early years provision

As a result of some weaknesses in the childminder's practice, some specific legal requirements are not met that impact on children's care. In addition, the childminder has not devised systems to show how children's progress is effectively supported and developed across the six areas of learning. However, children do benefit from the caring relationships they develop with the childminder and each other. Overall, their individual care needs are met.

Overall, the early years provision requires significant improvement. The registered person is given a Notice to Improve that sets out actions to be carried out.

What steps need to be taken to improve provision further?

To improve the early years provision the registered person should:

- ensure low level glass does not pose a risk to children
- improve fire safety precautions with a smoke detector on the ground floor
- share children's progress towards the early learning goals with parents and other settings where children may attend, encouraging their involvement in supporting children's progress and in making contributions to the assessment process
- develop a method of continuous self-evaluation

The leadership and management of the early years provision

The childminder has some awareness of her strengths and weaknesses, identifying that she lacks systems to ensure that children's continued learning and development is effectively supported through observations and assessment. However, she is not regularly evaluating her overall practice to identify and implement improvement.

There is limited sharing with parents and others about children's learning nor are they encouraged to be involved, for example with activities at home. As a result, they are not contributing to an assessment of children's progress. Parents are, however, encouraged to share what they know about their child's individual care needs and this helps supports children's overall welfare.

There is no risk assessment record in place that shows how the childminder protects and keeps children safe, inside the home and when on outings. She maintains most of the required records and documentation to help ensure the care needs of all children are met. Although, as she does not have written agreements with all parents, some necessary detail is not obtained. There is a well organised file of written policies and procedures that help inform parents about her childminding practices. These support her awareness of child protection and other procedures such as dealing with complaints.

The quality and standards of the early years provision

The childminder supports individual children's welfare needs. Whilst she has some awareness of the areas of learning and in how she can assist children's progress towards the early learning goals, there are no systems in place to effectively support their ongoing learning and development. She provides varied activities for children and children have access to a broad range of play materials, including a good number of resources that help children gain a positive awareness of others. Books are read together and children have some access to pens and paper for mark making, alongside the arts and craft activities. However, there is limited purposeful play planned for or observed that identifies and takes account of children's next steps, in their progress towards the early learning goals.

The premises are very clean and the childminder follows hygienic routines that help keep children healthy. For example, individual towels for hand drying help prevent cross contamination. Children are provided with healthy snacks and home

cooked meals, with reasonable access to drinks throughout the day enabling them to control their own thirst needs. Effective storage of food bought from home, helps prevent any perishables from spoiling. The childminder has an awareness of the need to take appropriate action when children are ill, injured or require medication. The house and garden are secure and children can explore their play space with most risks minimised, for example through the use of socket covers and cupboard catches in the kitchen. However, fire detection is less effective with no smoke alarm on the ground floor and there is no evidence that the low level glass is safe.

Positive and caring relationships exist between children and the childminder. As a result, children are settled and relaxed. Children's behaviour is supported by the childminder who is able to respond to their individual needs. The childminder keeps parents informed of their child's day, mostly with verbal feedback, concentrating more on care and welfare needs, than their learning and development.
