## Introduction

This inspection was carried out by Ofsted under Sections 49 and 50 of the Childcare Act 2006 on the quality and standards of the registered early years provision. 'Early years provision' refers to provision regulated by Ofsted for children from birth to 31 August following their fifth birthday (the early years age group). The registered person must ensure that this provision complies with the statutory framework for children's learning, development and welfare, known as the *Early Years Foundation Stage*.

The report includes information on any complaints about the childcare provision which Ofsted has received since the last inspection or registration whichever is the later, which require Ofsted or the provider to take action in Annex C.

The provider must provide a copy of this report to all parents with children at the setting where reasonably practicable. The provider must provide a copy of the report to any other person who asks for one, but may charge a fee for this service (The Childcare (Inspection) Regulations 2008 regulations 9 and 10).

Children only attend this setting before and/or after the school day and/or during the school holidays. The judgements in this report reflect the quality of early years provision offered to children during those periods.

The setting also makes provision for children older than the early years age group which is registered on the voluntary and/or compulsory part(s) of the Childcare Register. This report does not include an evaluation of that provision, but a comment about compliance with the requirements of the Childcare Register is included in Annex B.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states if the provider continues to meet the requirements of registration.

## **Description of the setting**

Swizzlink was registered in 2007. It is run by the Rosebank Centre and operates from designated areas within Ravenbank Community Primary School in Lymm, Cheshire. Children have access to the school outdoor area and associated facilities.

The setting provides out of school care for children from the local area and is open from 15.00 to 17.00 Monday to Thursday, term time only. A maximum of 50 children are cared for from the ages of three to eight years at any one time. There are currently no children on roll in the Early Years Foundation Stage. It is registered with the Early Years Register and on both the Voluntary and Compulsory parts of the Childcare Register.

Staff working with the children all hold relevant early years qualifications and will be taken from a bank of staff employed by the organisation.

## **Overall effectiveness of the early years provision**

The premises are warm and welcoming providing a good environment for young children. Space is organised well with age appropriate toys and equipment. All staff are suitably qualified and trained in the requirements of the Early Years Foundation Stage. Children's welfare is of paramount importance and this is reflected in stringent safeguarding procedures and thorough risk assessments.

The club has the capacity for continuous improvement and meets the requirements of registration.
