## Introduction

This inspection was carried out by Ofsted under Sections 49 and 50 of the Childcare Act 2006 on the quality and standards of the registered early years provision. 'Early years provision' refers to provision regulated by Ofsted for children from birth to 31 August following their fifth birthday (the early years age group). The registered person must ensure that this provision complies with the statutory framework for children's learning, development and welfare, known as the *Early Years Foundation Stage*.

The report includes information on any complaints about the childcare provision which Ofsted has received since the last inspection or registration whichever is the later, which require Ofsted or the provider to take action in Annex C.

The provider must provide a copy of this report to all parents with children at the setting where reasonably practicable. The provider must provide a copy of the report to any other person who asks for one, but may charge a fee for this service (The Childcare (Inspection) Regulations 2008 regulations 9 and 10).

The setting also makes provision for children older than the early years age group which is registered on the voluntary and/or compulsory part(s) of the Childcare Register. This report does not include an evaluation of that provision, but a comment about compliance with the requirements of the Childcare Register is included in Annex B.

## Description of the setting

Acorns playgroup was registered in June 2000. The playgroup is managed by a voluntary management committee made up of parents of children at the playgroup. The playgroup is registered on the Early Years Register, and the compulsory and voluntary parts of the Childcare Register. It operates from a classroom in the village primary school and serves the village of Whitstone and the surrounding area. It has links with the Early Years Foundation Stage provision of the primary school. A maximum of 16 children may attend the playgroup at any one time. Children from the age of three years to five years attend. The playgroup is open Monday, Wednesday and Thursday afternoons from 12:30 to 15:00, during school term times. All children share access to a secure enclosed outdoor play area. There are currently 12 children aged from three to under five years on roll. Of these, eight children receive funding for early education. The playgroup employs two members of staff. Of these, one holds appropriate early years qualifications and one is working towards a qualification. There is good access for those with disabilities.

## Overall effectiveness of the early years provision

The provision is good overall and provides a wide and varied curriculum that meets the requirements of the Early Years Foundation Stage and the needs of each individual. All aspects of the Every Child Matters agenda are met. The curriculum is fully inclusive and the provision provides for those with disabilities. There is good capacity to improve.

## What steps need to be taken to improve provision further?

To further improve the early years provision the registered person should:

- develop planning and curriculum further

## The leadership and management of the early years provision

Leadership and management are good and the leader is well supported by an active and well informed management group. They are constantly adapting and improving the provision to meet the needs of both the children and all statutory requirements. Records are kept of children's progress and staff have a good knowledge and understanding of their entry levels and progress made. Teaching is good and the relationships with pupils are excellent. Resources are targeted effectively and meet the needs of all age groups. Although the leadership and management have yet to complete their self-evaluation form they have a good understanding of the provision overall and what is required to improve.

Leadership and management have ensured all protection safeguards and recruitment procedures are in place and all other logs/registers are well

maintained. The children's welfare is paramount and there are good procedures in place to ensure this is maintained at all times. Partnerships with the school and other professionals is good and the provision is constantly working to improve this further.

The links with parents are excellent and communication is well established. All parents are part of the management group and the parents take this seriously. This link ensures all are fully informed of all aspects of the provision and discussion with parents supported comments made by the leadership and management. Parents are kept fully informed of all aspects of their child's learning and time in the provision. Handovers both at the start and finish of the sessions gives good feed back and reinforces more formal communication methods.

## **The quality and standards of the early years provision**

The quality and standards of the Early Years Foundation Stage provision is good overall. Teaching and learning is good. Children on entry are generally at levels expected for their age but leave slightly above average. The children's safety is ensured throughout and at all times and good procedures are in place to ensure this. Staff teach healthy living skills and reinforce safety issues with the children. Break times consist of healthy eating option with milk or water and a choice of various fruits. Discussion with the children demonstrated that they knew this was to keep them healthy and washing their hands ensured no germs. One child stated, 'We wash our hands to stop the germs. After we play and before we have break'.

Regular fire drills are held, usually in conjunction with the school and these are well logged. Accident records are well maintained and parents are fully aware of procedures for emergency situations. The staff have developed their understanding of child protection procedures and now fully understand all requirements.

Children fully enjoy their education and were keen to enter the provision and begin the well planned activities. These are focused sessions to develop various areas of learning but staff also ensure all areas of the curriculum are fully covered. Physical activities are encouraged and developed outside and the children really enjoy running around and doing a wide range of activities.

All activities observed encouraged language development and staff constantly interacted with the children and extended the ideas the children produced. The children interacted with each other really well and were polite and supportive throughout. Their social skills reinforce good general academic skills for their future economic well-being. The provision has good links with the school and the transition process is good. The leadership and management are fully aware of the need to enhance this link further by utilising the skills of the school's Early Years Foundation Stage to help develop their planning and curriculum further. The curriculum needs further extension with greater links to the local and wider community but again the staff are fully aware of this and are working to develop this.

Parental relationships are good and those parents spoken to were fully supportive of the provision and clearly knew and understood all procedures within the provision. The parents all being part of the management committee has created a greater understanding and enhanced parent/provision communication. Parents are fully aware of the complaints procedures and no complaints have been received.

Although there are only two members of staff they are well qualified for their roles and there are robust procedures in place to ensure the adequate staffing levels are maintained at all times.

All required documentation is in place at all times and well maintained. Children's records are detailed and planning is linked closely to these to ensure a high quality education and delivery.
