

## Inspection report for early years provision

## Introduction

This inspection was carried out by Ofsted under Sections 49 and 50 of the Childcare Act 2006 on the quality and standards of the registered early years provision. 'Early years provision' refers to provision regulated by Ofsted for children from birth to 31 August following their fifth birthday (the early years age group). The registered person must ensure that this provision complies with the statutory framework for children's learning, development and welfare, known as the *Early Years Foundation Stage*.

The report includes information on any complaints about the childcare provision which Ofsted has received since the last inspection or registration whichever is the later, which require Ofsted or the provider to take action in Annex C.

The provider must provide a copy of this report to all parents with children at the setting where reasonably practicable. The provider must provide a copy of the report to any other person who asks for one, but may charge a fee for this service (The Childcare (Inspection) Regulations 2008 regulations 9 and 10).

Children only attend this setting before and/or after the school day and/or during the school holidays. The judgements in this report reflect the quality of early years provision offered to children during those periods.

The setting also makes provision for children older than the early years age group which is registered on the voluntary and/or compulsory part(s) of the Childcare Register. This report does not include an evaluation of that provision, but a comment about compliance with the requirements of the Childcare Register is included in Annex B.

## **Description of the childminding**

The childminder was registered in 2005. She lives with her husband and their pre-school child in a house in Southampton. The premises are easily accessible from the road and close to local schools, shops and parks. Minded children have access to the ground floor of the property and a fully enclosed rear garden is available for outdoor play. The family have cats.

The childminder is registered to care for a maximum of five children under eight years at any one time, of whom no more than two may be in the early years age range. She is currently minding two children in this age group. She also offers care to five children aged over five years. This provision is registered by Ofsted on the compulsory and voluntary parts of the Childcare Register.

The childminder collects children from the local school and drops off and picks up from a pre-school.

## **Overall effectiveness of the early years provision**

Overall the quality of the provision is good. The childminder promotes well aspects of children's welfare, learning and development to ensure they are safe and progress through the early learning goals. She has a clear knowledge about adapting the environment, activities and resources to ensure all children are wholly involved. Records of children's progress and partnership with parents contribute to ensuring children's needs are met. The childminder uses self-evaluation to identify key strengths and weaknesses, which she is positive to address.

## **What steps need to be taken to improve provision further?**

To further improve the early years provision the registered person should:

- continue to build on and maintain effective working partnerships with parents, carers and other agencies in relation to children's learning and development
- improve daily records of children's activities to include further observation and assessment to more readily identify learning and development needs to extend children

## **The leadership and management of the early years provision**

The childminder is committed to promoting children's welfare and supporting their learning and development. Children are secure and happy in her care because she is professional in her approach to childminding. A range of policies and procedures are in place, ensuring that all aspects of children's welfare and learning are met. These are shared with parents and the children's information forms are completed, enabling the childminder to meet the needs of all the children who attend. The

childminder provides a caring approach and has implemented good health and hygiene procedures. The childminder has a good awareness of safeguarding issues. Appropriate safety equipment is in place and the childminder has considered how to keep children safe when they go on outings.

Parents spend time sharing information to help the childminder get to know their child in order to ease the settling-in process. Daily discussions are used to update parents on their child's care during the day. There are arrangements in place for working together with other carers to support children's learning and development. This has yet to be developed as it is in its infancy. The childminder can identify her own strengths and weaknesses to address her practice. Some thought has been given to identifying areas for improvement. For example, the childminder talks about improving her written observations of the children and activities to include further assessment and photographs; to more readily identify learning and development needs to extend children.

## **The quality and standards of the early years provision**

Children are learning because the childminder provides an environment where they are encouraged to develop their independence. Children select accessible resources they wish to play with from a variety of toys suited to their stage of development. They enjoy a mix of adult-led activities and child-initiated play. For example a child is interested in volcanoes, so the childminder helps the child research the subject using reference books. This is further extended when the children make a volcano. The childminder supports their learning. Evidence shows that children enjoying creative activities, such as making Mother's Day flower pots and planting miniature roses in them, being outdoors and being occupied with various age appropriate resources. The childminder has a knowledge of children's learning and development needs. She is planning on evaluating her observations and taking more photographs of the children engrossed in activities to record their progress towards the early learning goals.

Children learn how to keep themselves safe from an early age as the childminder reminds them not to run in the home in case they fall and hurt themselves. The childminder has organised her home well to provide plenty of space for children to move around freely. Children have daily opportunities to benefit from fresh air and exercise through visits to the park and other local attractions. The childminder encourages children to develop healthy eating habits and liaises with parents and children to provide nutritious light meals and snacks. Children enjoy cooking activities, such as making heart biscuits for Valentine's Day. They are beginning to learn a good sense of right and wrong because the childminder implements clear rules and boundaries consistently. As a result, the children know what is expected of them and are keen to follow simple instructions, knowing it will lead to praise and recognition of their efforts. The childminder reminds the children of the rules, gently and calmly, building their self-esteem and confidence effectively. Children are developing respect for others. For example, children are beginning to show consideration for others as they pass the toys and help each other throughout the day. The childminder helps young children to develop their language through speaking clearly and listening intently to what children say to her. This gives

children the confidence to practise their speech, and to develop a wider vocabulary whilst they play.
