#### Introduction

This inspection was carried out by Ofsted under Sections 49 and 50 of the Childcare Act 2006 on the quality and standards of the registered early years provision. 'Early years provision' refers to provision regulated by Ofsted for children from birth to 31 August following their fifth birthday (the early years age group). The registered person must ensure that this provision complies with the statutory framework for children's learning, development and welfare, known as the *Early Years Foundation Stage*.

The report includes information on any complaints about the childcare provision which Ofsted has received since the last inspection or registration whichever is the later, which require Ofsted or the provider to take action in Annex C.

The provider must provide a copy of this report to all parents with children at the setting where reasonably practicable. The provider must provide a copy of the report to any other person who asks for one, but may charge a fee for this service (The Childcare (Inspection) Regulations 2008 regulations 9 and 10).

Children only attend this setting before and/or after the school day and/or during the school holidays. The judgements in this report reflect the quality of early years provision offered to children during those periods.

The setting also makes provision for children older than the early years age group which is registered on the voluntary and/or compulsory part(s) of the Childcare Register. This report does not include an evaluation of that provision, but a comment about compliance with the requirements of the Childcare Register is included in Annex B.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states if the provider continues to meet the requirements of registration.

#### Description of the setting

Just William Club was registered in August 2004. It operates from the William Levick Primary School in Dronfield Woodhouse. The club has access to a reception, a base room which includes the kitchen area, library, baking area and the main hall. There is a secure, outside play area. The after school club primarily serves the primary school. There were no Early Years Foundation Stage (EYFS) children on roll at the time of the inspection. Children attend from 3 years of age to 11 years of age. The club opens five days a week Monday to Friday. Term time sessions are from 07:45 to 09:00 and 15:00 to 18:00 and school holiday sessions are from 07:45 to 18:00. The three full-time and two part-time staff work with the children. Of these four have early years qualifications at Level 3 and one has an early years qualification at Level 2. Staff or children with disabilities are suitably catered for with most of the accommodation being on one level and other areas being accessible from the outside of the building. Provision is in place to ensure those children with learning difficulties or who are in the early stages of learning English as an additional language can be included suitably. The club is a limited company and is supported by the Early Years Childcare Network. It is on the Early Years, compulsory and the voluntary parts of the Childcare Register.

#### Overall effectiveness of the early years provision

There were no children of this age group on roll at the time of the inspection. However, the provider was able to demonstrate the suitability of the setting and staff for the intended care and education of children of this age group. As a result, the setting meets the various registration requirements. The provider was able to demonstrate knowledge of the documentation requirements and that the required policies and procedures are in place. The appropriate records are in place for when looking after children. All parts of the premises intended to be used for childcare are safe, secure and suitable for their purpose. Toys, play materials and equipment are of suitable design and condition, and help to provide a stimulating environment for children. A member of staff holding a current first aid certificate is on the premises at all times when children are present. Through documentation and discussion the provider is able to demonstrate a suitable understanding of the EYFS and how children develop, in order to appropriately inform the provision for care and learning. Parents interviewed speak positively about the provision. Recommendations from the last inspection have been addressed fully. This is through the introduction of systems to ensure that parents sign to acknowledge entries in a medication record book. Regular risk assessments are carried out for the outdoor play area. Setting staff also work with the EYFS children in the school on a daily basis and undergo relevant and up-to-date training.
