



## **About this inspection**

The purpose of this inspection is to assure children and young people, parents, the public, local authorities and government of the quality and standard of the service provided. The inspection was carried out under the Care Standards Act 2000.

This report details the main strengths and any areas for improvement identified during the inspection. The judgements included in the report are made in relation to the outcome for children set out in the Children Act 2004 and relevant National Minimum Standards for the establishment.

#### Service information

#### Brief description of the service

The school is registered to accommodate 22 children and young people from the ages of eight to under18 years. At the time of the inspection, 21 children and young people were being accommodated. The school provides education and care to children and young people who present with severe learning disabilities, challenging behaviours, autistic spectrum disorder and associated epilepsy. The school is approved and registered by the Department for Children, Schools and Families (DCSF). The interior of the downstairs of the house is split into four main communal areas and these comprise of a large lounge, a kitchen and diner with adjoining bathroom and toilet facilities. The children and young people are grouped in terms of age and compatibility. The Lodge provides accommodation for young people with an age range from 16 to 18 years. The home's remit is to provide opportunities to develop independent living skills.

#### **Summary**

This inspection was an interim unannounced visit. At the previous key inspection, the home was judged as achieving an overall good outcome. Staying safe, enjoying and achieving and economic well-being, positive contribution and organisation were judged good. Being healthy was judged as outstanding.

The outcome group for staying safe is judged at this inspection visit. Informal discussions were held with staff and management. Children and young people were present at the time of the inspection.

The overall quality rating remains good. Children and young people continue to receive a good standard of care.

There are no actions or recommendations being set as a result of this visit.

## Protecting children from harm or neglect and helping them stay safe

The provision is good.

Children and young people continue to live in a caring and safe environment. Staff understand their responsibility to safeguard and promote the welfare of children and young people in their care. Staff are able to act on concerns and make an appropriate referral to the Local Safeguarding Children Board. Since the last inspection, there has been one child protection event, which is currently being concluded.

The home has in place suitable policies for addressing complaints, counteracting bullying, behaviour management and health and safety. This ensures that best practice is successfully adopted and that children and young people receive safe and effective care. Staff are provided with clear policies and procedures that cover safe care, privacy and confidentiality. This helps maintain the dignity and privacy of children and young people and therefore protecting their rights.

Children and young people are provided with good levels of staff supervision and their whereabouts are known at all times.

The home requires all staff to be responsive to any difficulties encountered by children and young people living at the home. The home has good procedures in place for dealing with complaints. Records show the occurrence, content, and resolution of complaints, which indicates a transparent and professional approach is taken by the Registered Manager.

The home effectively addresses bullying by ensuring that the policy is available and known to staff and children and young people. Staff ensure the policy is implemented, monitored and revised as necessary.

Children and young people learn appropriate ways of interacting with each other. Children and young people's challenging behaviours are confidently managed. Staff provide a supportive environment for children and young people that reflects their individual preferences, needs and strengths.

Staff understand that they are responsible for health and safety in relation to the children and young people under their supervision. Staff continue to use documented risk assessments effectively to demonstrate how children and young people are protected and that risks are minimised and managed safely. Children and young people are further protected because they have regular opportunities to participate in fire evacuation practices so that they know what to do in the event of an emergency.

The home ensures that staff working at the home are deemed suitable to work with children and young people. Staff records checked show a consistent and sound approach to safe recruitment procedures.
