Outcome of monitoring visit for provision judged as inadequate

An Ofsted inspector, Martha Naa Ahimah Darkwah, carried out a monitoring visit of your provision on 25/08/2009. This visit follows on from your inspection where the provision was judged to be inadequate.

Outcome of the visit

As a result of our inspection on 20/07/2009, we sent you a notice to improve.

This notice required you to plan and provide a suitable range of activities to ensure children receive an enjoyable and challenging learning and development experience that is tailored to their individual needs.

An additional notice required you to provide and action plan of how you will ensure that the provision has the sole use of the premises during the hours of operation.

Having considered all the evidence, the inspector is of the opinion that at this time the setting is making satisfactory improvement overall.

Overall effectiveness of the improvement and outcomes for children

During the monitoring visit the evidence found demonstrates that overall, the registered provider and staff members have made satisfactory progress on the two notices to improve as outlined above.

There is an ongoing system in place to ensure suitable activities are planned to meet children's needs. For example, children attending the holiday club engage in structured activities. In the setting, they are offered a differing range of activities and by making good use of the local amenities such as the park, bowling alley and cinema, children have access to additional activities outside the setting. Weekly planning sheets are used for learning opportunities such as reading, art, singing and dancing.





The provider produced an action plan detailing how the setting is going to meet the requirement of ensuring sole use during hours of operation. Evidence found during the visit shows that children are safeguarded within the confines of the premises with a system in place for dedicated staff looking after their needs.

Overall the provider has made satisfactory progress in making improvements to the setting's practice. The providers continues to work towards structured systems and action plans which has a positive impact for children enabling them to be provided with a suitable range of activities which are enjoyable and challenging learning and development experience that is tailored to their individual needs.

The provider has identified potential for further improvement within the action plan that by the end of the winter term next year, the club will have exclusive use of the premises during its operational hours.

Next steps

Having considered all the evidence the inspector is of the opinion that at this time:

• The setting has made satisfactory progress in addressing the points for improvement. The next visit will be a full inspection.
