Outcome of monitoring visit for provision judged as inadequate

An Ofsted inspector, Stuart Busbridge, carried out a monitoring visit of your provision on 12/11/2009. This visit follows on from your inspection where the provision was judged to be inadequate.

Outcome of the visit

As a result of our inspection on 29/04/2009, we sent you a notice to improve.

These notices required you to ensure that a suitably qualified manager is in place at all times, ensure that Ofsted are notified of significant events, ensure that those looking after babies are suitably qualified and experience to care for children in the age group, devise and implement an effective key working system to ensure that all children's needs are fully supported, develop staffs knowledge and understanding of the Early Years Foundation Stage and provide planned experiences which are appropriate to each child's stage of development as they progress towards the early learning goals, keep a record of complaints and subsequent action taken, ensure all staff who are in contact with children have relevant enhanced criminal record bureau checks appropriate to working with children.

Having considered all the evidence, the inspector is of the opinion that at this time the setting is making satisfactory improvement overall.

Overall effectiveness of the improvement and outcomes for children

Since the last monitoring visit the provider has made sustainable progress in meeting all of the notices to improve. All staff are suitably qualified and there is a qualified manager in place at all times. Ofsted has been informed of significant events in advance and on the day of the initial monitoring visit. Children of all age groups are supervised by suitably qualified staff. Activities are well planned based on children's individual needs and abilities. The key working system is progressing well and children are benefiting from the staff having clear understanding of children have



achieved and where they go next in relation to the early years goal. The provider is aware that the complaints log needs to be kept up to date and all current staff have relevant enhanced criminal record bureau checks.

Due to the continued improvements made since the last monitoring visit the provider now demonstrates that their have achieved sustainable progress and the next visit will be a full inspection.

Next steps

Having considered all the evidence the inspector is of the opinion that at this time:

• The setting has made satisfactory improvement. The next visit will be a full inspection.
