Introduction

This inspection was carried out by Ofsted under Sections 49 and 50 of the Childcare Act 2006 on the quality and standards of the registered early years provision. 'Early years provision' refers to provision regulated by Ofsted for children from birth to 31 August following their fifth birthday (the early years age group). The registered person must ensure that this provision complies with the statutory framework for children's learning, development and welfare, known as the *Early Years Foundation Stage*.

The provider must provide a copy of this report to all parents with children at the setting where reasonably practicable. The provider must provide a copy of the report to any other person who asks for one, but may charge a fee for this service (The Childcare (Inspection) Regulations 2008 regulations 9 and 10).

Children only attend this setting before and/or after the school day and/or during the school holidays. The judgements in this report reflect the quality of early years provision offered to children during those periods.

The setting also makes provision for children older than the early years age group which is registered on the voluntary and/or compulsory part(s) of the Childcare Register. This report does not include an evaluation of that provision, but a comment about compliance with the requirements of the Childcare Register is included in Annex B.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states if the provider continues to meet the requirements of registration.

Description of the setting

The Playstation opened in August 2001 and is managed by a voluntary management committee. It operates from rooms within Gibside School, a school for children with varying special educational needs and/or disabilities, including challenging behaviour. There is access to enclosed outdoor playgrounds. The group is registered by Ofsted on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. A maximum of 20 children may attend at any one time. There are currently 26 children on roll, all of whom are over the age of 5. The setting is open Monday to Friday from 3.30pm to 6 pm, during term-time only. The children who attend come from the host school which takes children from a diverse geographical area within Gateshead, offering a return transport service at the end of each session.

The group employs 10 members of staff who work directly with the children. All of these except one is qualified to level 3 in an appropriate qualification.

The overall effectiveness of the early years provision

Experienced, and skilful staff have appropriate systems in place overall for the support of children's individual needs. Suitable vetting and recruitment procedures are in place to ensure staff are suitable to work with children. Resources, such as toys, and arrangements for staffing meet requirements. Managers have developed an ethos of play and free choice that complements school life so that children can receive different opportunities in the club.

However, weak self-evaluation of the provision has resulted in some aspects of practice relating to risk assessments, safeguarding policies and information for parents, not meeting the requirements of the Early Years Foundation Stage. Written information prepared for parents contains examples of some policy documentation but does not include written statements about safeguarding or full details of Ofsted's current address. This is a breach of the legal requirements. Leaders, however, are passionate about addressing the issues and alongside the positive partnership with the school and a willingness to seek external support, there is satisfactory capacity to improve.
