ABOUT THIS INSPECTION

The purpose of this inspection is to assure government, parents and the public of the quality of childcare and, if applicable, of nursery education. The inspection was carried out under Part XA Children Act 1989 as introduced by the Care Standards Act 2000 and, where nursery education is provided, under Schedule 26 of the School Standards and Framework Act 1998.

This report details the main strengths and any areas for improvement identified during the inspection. The judgements included in the report are made in relation to the outcomes for children set out in the Children Act 2004; the National Standards for under 8s day care and childminding; and, where nursery education is provided, the *Curriculum guidance for the foundation stage.*

THE QUALITY AND STANDARDS OF THE CARE

On the basis of the evidence collected on this inspection:

The quality and standards of the care are good. The registered person meets the National Standards for under 8s day care and childminding.

WHAT SORT OF SETTING IS IT?

Invicta Out of School Club has been registered since April 2005. It operates from 15:15 to 18:00 from Invicta Community Centre, Stanfield Close, Plumstead in the London Borough of Greenwich. The club has use of the hall, toilets and kitchen. Children are collected from Bannock Burn and Gallion's Mount Schools.

The club is registered for a maximum of 24 children at any one time. Children over the age of 8 years also attend. There are 17 children currently on roll of whom 9 are under 8 years. The club works to a ratio of 1 member of staff to 8 children.

THE EFFECTIVENESS OF THE PROVISION

Helping children to be healthy

The provision is good.

The provision promotes children's good health and hygiene. Children understand the importance of washing their hands before snack time and after going to the toilet. Children are protected from the spread of infection as sick children are excluded from attending the after school club. Although the building is in need of redecorating staff work hard to ensure that the hall, kitchen area and toilets are kept clean. The club follows the school's non medication policy by not allowing children to bring medication into the club other than asthma inhalers which children are encouraged to administer themselves. Parent's provide written consent for staff to seek emergency medical advice/treatment. Staff's up to date knowledge of first aid helps to ensure children are cared for appropriately in the event of accidents.

Children benefit from physical exercise walking from school to the club and taking part in physical activities such as skipping and hula hoops. The club is in the process of applying for funding to make the outside play area safe and suitable for registration.

At tea time children benefit from a choice of healthy snacks and drinks which are prepared by staff while children stand and queue. Snacks include sandwiches with different fillings, fresh fruit and raw vegetables and biscuits. Children understand that fruit is good for them however, some parents have requested that children are only offered biscuits and a piece of fruit as they have a cooked meal when they get home.

Protecting children from harm or neglect and helping them stay safe

The provision is good.

The provision has good procedures in place for keeping children safe and protecting them from harm. On the journey from school children walk in pairs and know that they must not turn around to talk to the person behind in case they trip over. Staff talk to children about road safety. The front door is kept locked to prevent children from leaving the building unsupervised and to prevent unwanted visitors from gaining access. Staff carry out regular risk assessments to ensure that the premises are safe, secure and free from hazards. Children take part in regular fire drills which are recorded. Furniture, toys and equipment are appropriate for their purpose in, satisfactory condition and are checked regularly for broken pieces and cleanliness.

Children are protected by the staff's sound knowledge of child protection and the appropriate vetting of staff members.

Helping children achieve well and enjoy what they do

The provision is good.

Children are happy, confident and thoroughly enjoy their time spent at the after

school club playing together and relaxing in a friendly atmosphere. Children choose what they want to do from a range of activities which include various games, such as Twister, Frustration, Connect 4, Who's Who and Hooked, painting, drawing, circus tricks and table pool. The group has just received a grant and with children's help have devised a wish list which includes a computer, large dolls house, book corner with cushions and lots of new table toys and games.

Children benefit from good adult support as staff sit with them and join in games such as Connect 4 and Frustration and take part in activities such as spinning plates and juggling. Staff engage children in conversations and encourage them to talk about events at school and at home.

Helping children make a positive contribution

The provision is good.

The after school club is open to all children currently attending Bannockburn School and Galion's Mount School regardless of culture, religion, race, language or disability. Children come from a mix of different cultural backgrounds. They learn to respect one another's differences by playing together and talking to one another. Discrimination in any form is not tolerated and this is supported by the club's equal opportunities policy. Comprehensive child record forms provide staff with information to meet children's individual needs.

Strategies for managing children's behaviour are consistent with the clubs behaviour management policy which promotes positive reinforcement. Staff act as good role models and have high expectations of children's behaviour. Clear rules and boundaries help children to behave well. Children respond positively to lots of praise and encouragement as they share, take turns and play well together.

Good relationships with parents contribute to children's care and well being. New parents are provided with a hand book containing lots of information about the after school club including summaries of several policies and procedures. Parents collecting children are greeted warmly by staff and often stop to chat. The after school club has a written complaints procedure however, there is no procedure in place for the recording of complaints as required under the new guidance.

Organisation

The organisation is good.

Children benefit from qualified and experienced staff who are committed to providing a safe, healthy and enjoyable environment in line with the National Standards. Rigorous recruitment procedures ensure that appropriate and suitable staff are employed to work with children and that unvetted staff are never left alone with children. Staffing ratios are maintained at one member of staff to eight children. Good organisation of space and resources allows children to play safely and make independent choices.

All necessary documentation is in place and includes a record of children's attendance and accidents which are signed by parents, signed consent forms and comprehensive child information forms. A set of policies and procedures contribute to the care, safety and well being of the children.

The setting meets the needs of all the children for whom it provides.
