ABOUT THE INSPECTION

The purpose of this inspection is to assure government, parents and the public of the quality and standard of day care. When making judgements, inspectors have regard to how well the provider meets the National Standards for under Eights Day Care and Childminding. A list of these is attached. The report identifies strengths and areas for improvement.

This inspection report must be made available to all parents.

Information about the setting

Kids Unlimited at Bramingham Park opened in 2004. It operates from seven rooms in a purpose built building and is situated on the parameters of a residential area on the outskirts of the town of Luton. A maximum of 134 children attend the nursery at any one time. The nursery is open each weekday from 07:30 to 18:30 for 51 weeks of the year. All children share access to a secure enclosed outdoor play area.

There are currently 114 children from nought to eight years on roll, 45 of these receive funding for nursery education. Children come from a wide catchment area, as the nursery is located on the outskirts of town. The nursery currently supports a child with special needs, and there are systems in place to support children who speak English as an additional language.

A total of 32 staff work at the nursery, 21 of the staff have early years qualifications to level 2 or 3. Two staff members are working towards a recognised early years qualification. Staff receive support from an early years advisory teacher.

How good is the Day Care?

Kids Unlimited at Bramingham Park provides satisfactory care overall for young children.

The nursery has thorough written operational procedures, however significant changes to the organisational structure and philosophy of care has impacted on the smooth operation of the setting. New interior décor is minimalist. The rooms have specific colour bonds and the emphasis of provision is towards natural and real life objects. A majority of the age groups have benefited from the change, however the diversity of equipment and suitability of the environment for the younger babies has been affected. The youngest baby room is bright, stark and unwelcoming. Children have difficulty settling and sleep patterns are interupted. Staff work hard to meet the individual care needs of the children, but are left with little time for purposeful play. Although activities are prepared they remain untouched.

The nursery has vigorous Health and Safety procedures in place. Senior staff monitor the security, safety and welfare of the children on the premises. Accidental injuries are notified to management. Records are monitored and link to risk assessment reviews. The nursery have an exceptional food programme which supports children's individual dietary needs well. The nursery welcomes all children,

although resources that promote positive images are limited.

Overall staff provide a range of developmental activities to support and extend learning. However, poor team work impedes on the quality of care provided. Staff are rigid in their duties. For example they sit at set activities, but do not respond to the child that requests a story to be read, although overall ratios are high. Staff oversee rather than interact in order to complete their tasks. Children know the daily routine well and behaviour is good.

The nursery has satisfactory relationships with parents. There are systems in place to support the exchange of information.

What has improved since the last inspection?

What is being done well?

- The nursery have a three tier management structure. The strong management team have effectively implemented the new organisational changes and are continuing to support their staff team in developing their styles of practice within the philosophy and structure of the Kids Unlimited protocols.
- The nursery have in place an exceptional food programme. Careful
 monitoring by company nutritionalists ensure children receive a well balanced
 and varied diet. Consideration is given to providing alternative provision in
 order to meet individual dietary needs. The cook, catering assistant and staff
 demonstrate a clear understanding and knowledge of maintaining parents
 wishes in relation to foods provided.
- Children are gently nurtured in learning socially acceptable behaviour from an early age. Children are supported to play together co-operatively, share and take turns where appropriate. Staff suitably implement the companies policy and are consistent in their messages to children.

What needs to be improved?

- the environment for young babies in order to promote a suitable area in which normal life experiences are maintained
- the monitoring of registers to ensure compliance to the standards
- the organisation and effectiveness of teamwork to ensure ratios are complied with and staff interaction and engagement with children is effective
- resources for the younger age group in addition to resources that promote positive images throughout the setting.

PREVIOUS COMPLAINTS (This section applies only to inspections carried out from September 2004. The complaint record relates to complaints from the last inspection or 1st April 2004 whichever is later.)

Concerns were raised regarding Standard 1 (Suitability), Standard 2 (Organisation), Standard 4 (Physical Environment), Standard 6 (Safety) and Standard 7 (Health and Hygiene).

Ofsted investigated by carrying out an unannounced visit 19/08/2004.

The outcome of the visit was that a total of eleven actions were issued. One action under Standard 1 (Suitability), four actions under Standard 2 (Organisation), one under Standard 4 (Physical Environment), one under Standard 6 (Safety) and two under Standard 7 (Health and Hygiene). Ofsted has checked these actions and they have been met. The provider remains qualified for registration.

Concerns were raised regarding Standard 8 (Food and Drink) and Standard 12 (Working in Partnership with Parents and Carers).

Ofsted investigated by carrying out an unannounced visit on 04/10/04.

Two Actions under Standard 11(Behaviour Management) and Standard 13 (Child Protection) and three Recommendations under Standard 2 (Organisation), Standard 8 (Food and Drink), Standard 12 (Working in Partnership with Parents and Carers) were issued following the visit. Ofsted has checked the actions and they have been met. The provider remains qualified for registration.

Concerns were raised relating to Standard 2 (Organisation) relating to the presence of suitable and qualified managers and deployment of staff.

Ofsted investigated by carrying out an unannounced visit on 14/10/04. Evidence found by Ofsted at that visit was sufficient to issue three Compliance notices relating to Standard 2 (Management and records) and Standard 14 (notifying Ofsted of significant incidents), with a further two actions relating to Standard 2(records) and Standard 13 (Child Protection) issued following the visit. Ofsted made a further visit on 09/11/2004 to check that the Compliance notices had been met. The nursery had complied with the notices issued. The provider remains qualified for registration.

Outcome of the inspection

All registered persons must comply with all conditions of registration included on his/her certificate of registration.

As a result of this inspection conditions of registration have been imposed / varied / removed and a new certificate of registration will be issued.

SUMMARY OF NATIONAL STANDARDS

The premises are safe, secure and suitable for their purpose. They provide adequate space in an appropriate location, are welcoming to children and offer access to the necessary facilities for a range of activities which promote their development.

Adults caring for children in the provision are able to manage a wide range of children's behaviour in a way which promotes their welfare and development.

STANDARD 12 - WORKING IN PARTNERSHIP WITH PARENTS AND CARERS

The registered person and staff work in partnership with parents and to meet the needs of the children, both individually and as a group. Information is shared.

STANDARD 13 - CHILD PROTECTION

The registered person complies with local child protection procedures approved by the Area Child Protection Committee and ensures that all adults working and looking after children in the provision are able to put the procedures into practice.

STANDARD 14 - DOCUMENTATION

Records, policies and procedures which are required for the efficient and safe management of the provision, or to promote the welfare, care and learning of children are maintained. Records about individual children are shared with the child's parent.
