ABOUT THE INSPECTION

The purpose of this inspection is to assure government, parents and the public of the quality and standard of day care. When making judgements, inspectors have regard to how well the provider meets the National Standards for under Eights Day Care and Childminding. A list of these is attached. The report identifies strengths and areas for improvement.

This inspection report must be made available to all parents.

Information about the setting

Watermead Nursery opened in 2004 and operates from six rooms within the setting which is situated on the edge of a residential area in Nanpantan Loughborough. The nursery serves the local and surrounding areas. A maximum of 45 children may attend the nursery at any one time. The nursery is open each weekday from 07:45 to 18:00 all year round. All children share access to a secure enclosed outdoor play area.

There are currently 58 children aged from 0 to under 5 years on roll. Of these seven children receive funding for nursery education.

The nursery employs 12 staff in addition to the manager, all of whom hold appropriate early years qualifications. The nursery of members of the National Day Nursery Association.

How good is the Day Care?

Watermead Day Nursery provides good quality care for children. Staff have a good knowledge of the National Standards and supporting criteria, they work well as a team and are fully involved in planning, evaluating and developing practice. The comfortable premises provide a warm and caring environment offering scope for a range of indoor and outdoor opportunities, including active play and relaxation. The operational plan works very well in practice, procedures for deputising are effective and good use is made of staff, space and resources. Documentation is clearly presented, however reference to the Disability Discrimination Act 1995 is not included in the special needs policy.

Good attention is given to ensure the premises are safe and secure and effective policies and procedures are implemented which have a positive impact on the safety and welfare of the children. Staff have a high regard to children's health and safety. They recognise children as individuals meeting their differing needs well and implement child protection procedures which are robust and fully understood to work in practice.

Play activities are well planned and presented to allow children to develop necessary and important skills and offer exciting and interesting opportunities to enhance their overall development. Excellent provision is available for babies and infants. Behaviour is managed well and children are confident and well behaved and

respond to consistent expectations.

Staff build positive relationships with parents to provide consistent care for children and there are effective recording systems to ensure parental views are acknowledged and respected. Parents receive very good information about the setting with a clearly written and informative prospectus. Good quality records containing important information about children's progress are maintained. Staff are available to discuss issues on a daily basis and there are good opportunities to share children's progress.

What has improved since the last inspection?

What is being done well?

- The premises, including the outside area, are safe and secure. Written
 information, wall displays and photographic evidence of the children at play
 provides a warm welcoming atmosphere where an environment to nurture
 and care for children is maintained.
- Children's progress is enhanced with a wide variety of age appropriate play opportunities. Older and more able children are encouraged to select and access activities independently with good support from staff to promote their confidence and self esteem. Excellent provision is available for babies and infants.
- Effective systems and routines ensure all areas accessed by the children are clean and well maintained. Staff promote children's health, safety and welfare with clear understanding of comprehensive policies and procedures. The ongoing risk assessment ensures a safe environment is maintained and that potential risks are minimised.
- Effective records are maintained to ensure the children's individual needs are discussed and recorded. Well written documentation, resources and staff awareness ensures that all children are included and have equal opportunities to enhance their learning and play.
- Staff establish positive relationships with parents and information relating to the setting is easily accessible. There is an effective system in place for the regular exchange of information to keep parents fully informed of their child's progress.

SUMMARY OF NATIONAL STANDARDS

STANDARD 1 - SUITABLE PERSON

Adults providing day care, looking after children or having unsupervised access to them are suitable to do so.

STANDARD 2 - ORGANISATION

The registered person meets required adult: child ratios, ensures that training and qualifications requirements are met and organises space and resources to meet the children's needs effectively.

The registered person meets children's individual needs and promotes their welfare. They plan and provide activities and play opportunities to develop children's emotional, physical, social and intellectual capabilities.

STANDARD 4 - PHYSICAL ENVIRONMENT

The premises are safe, secure and suitable for their purpose. They provide adequate space in an appropriate location, are welcoming to children and offer access to the necessary facilities for a range of activities which promote their development.

STANDARD 5 - EQUIPMENT

Furniture, equipment and toys are provided which are appropriate for their purpose and help to create an accessible and stimulating environment. They are of suitable design and condition, well maintained and conform to safety standards.

STANDARD 6 - SAFETY

The registered person takes positive steps to promote safety within the setting and on outings and ensures proper precautions are taken to prevent accidents.

STANDARD 7 - HEALTH

The registered person promotes the good health of children and takes positive steps to prevent the spread of infection and appropriate measures when they are ill.

STANDARD 8 - FOOD AND DRINK

Children are provided with regular drinks and food in adequate quantities for their needs. Food and drink is properly prepared, nutritious and complies with dietary and religious requirements.

STANDARD 9 - EQUAL OPPORTUNITIES

The registered person and staff actively promote equality of opportunity and anti-discriminatory practice for all children.

STANDARD 10 - SPECIAL NEEDS (INCLUDING SPECIAL EDUCATIONAL NEEDS AND DISABILITIES)

The registered person is aware that some children may have special needs and is

proactive in ensuring that appropriate action can be taken when such a child is identified or admitted to the provision. Steps are taken to promote the welfare and development of the child within the setting in partnership with the parents and other relevant parties.

STANDARD 11 - BEHAVIOUR

Adults caring for children in the provision are able to manage a wide range of children's behaviour in a way which promotes their welfare and development.

STANDARD 12 - WORKING IN PARTNERSHIP WITH PARENTS AND CARERS

The registered person and staff work in partnership with parents and to meet the needs of the children, both individually and as a group. Information is shared.

STANDARD 13 - CHILD PROTECTION

The registered person complies with local child protection procedures approved by the Area Child Protection Committee and ensures that all adults working and looking after children in the provision are able to put the procedures into practice.

STANDARD 14 - DOCUMENTATION

Records, policies and procedures which are required for the efficient and safe management of the provision, or to promote the welfare, care and learning of children are maintained. Records about individual children are shared with the child's parent.
