#### **ABOUT THE INSPECTION**

The purpose of this inspection is to assure government, parents and the public of the quality and standard of day care. When making judgements, inspectors have regard to how well the provider meets the National Standards for under Eights Day Care and Childminding. A list of these is attached. The report identifies strengths and areas for improvement.

This inspection report must be made available to all parents.

## Information about the setting

The Children's House is a private nursery which opened in 2000.

It is accommodated in purpose built premises on two sites in Stallingborough in North East Lincolnshire. The nursery offers child care to the local community and surrounding areas and is in the process of gaining Independent School status and promotes Montessori teaching methods.

It provides full day care for up to 132 children aged nought to twelve years Monday - Friday 07:00 - 19:00- full year. Sessions operate 09:00 -13:00 and 13:30 - 17:30. They offer out of school care 07:15 - 08:45 and 15:30 - 19:00, collecting and delivering children to Keelby and Stallingborough Schools.

There are four playrooms and the nursery has all appropriate facilities including toilets, kitchen and storage space. The school site has one classroom in use at this time. The group has a secure outdoor play space and is part of a working farm.

There are currently 113 children on register and 18 are funded three year olds and 14 funded four year olds. There are two children with special educational needs attending the group and none for whom English is an additional language.

The nursery has 26 staff working on a full and part time basis, 17 staff hold a recognised early years qualification, four are working towards qualifications and five are unqualified. The nursery has two administrators and four ancillary staff. The nursery are members of the Early Years Development and Childcare Partnership and co-ordinators of the local branch of the National Day Nurseries Association.

## **How good is the Day Care?**

The Children's House provides good provision for children aged from nought to eight years. Sessions are planned and organised by the experienced staff team who are committed to ongoing training both in-house and externally. Staff are appropriately qualified or working towards relevant child care qualifications. They interact very effectively with children to support their learning and development.

Children are motivated and interested to learn accessing equipment and activities which support their all round development.

Staff provide positive role models and promote good behaviour which is valued.

The group give excellent support to children with special needs and work very effectively with parents and other professionals.

Partnership with parents is very positive. There is a key worker system in operation and parents are given good quality information. Children are looked after according to parents wishes. Parents are very happy with the enthusiasm and commitment of the staff team, the superb environment and excellent facilities.

Most required policies and procedures are in place and records are stored securely.

## What has improved since the last inspection?

## What is being done well?

- Staff know the children well and give excellent attention to meeting children's individual needs. The children are happy and settled and access activities both indoors and out independently.
- Effective planning for children of all ages ensures children learn and develop in a stimulating, sensory environment. Activities are very well planned to accommodate children's age and stage of development. Children are encouraged to be self driven learners.
- Reflective practice and commitment to ongoing training ensures all staff have a clear understanding of their role.
- Dietary needs are discussed and an organic food programme is in place which promotes healthy eating.
- The provision has a superb range of Montessori equipment, toys and furniture to meet the needs of the children.
- Good behaviour is valued praised and encouraged.
- Staff support children with special needs well and work effectively with parents and other professionals. Staff create a positive environment which promotes caring and cooperation, children are helped to be sensitive to the needs and feelings of others.
- The management of the Children's House is excellent and the group are working towards the accreditation of Investors in People.
- Relationships with parents are very positive, children are looked after according to parents wishes.

#### **SUMMARY OF NATIONAL STANDARDS**

#### STANDARD 1 - SUITABLE PERSON

#### **STANDARD 7 - HEALTH**

The registered person promotes the good health of children and takes positive steps to prevent the spread of infection and appropriate measures when they are ill.

## **STANDARD 8 - FOOD AND DRINK**

Children are provided with regular drinks and food in adequate quantities for their needs. Food and drink is properly prepared, nutritious and complies with dietary and religious requirements.

#### **STANDARD 9 - EQUAL OPPORTUNITIES**

The registered person and staff actively promote equality of opportunity and anti-discriminatory practice for all children.

# STANDARD 10 - SPECIAL NEEDS (INCLUDING SPECIAL EDUCATIONAL NEEDS AND DISABILITIES)

The registered person is aware that some children may have special needs and is

proactive in ensuring that appropriate action can be taken when such a child is identified or admitted to the provision. Steps are taken to promote the welfare and development of the child within the setting in partnership with the parents and other relevant parties.

#### **STANDARD 11 - BEHAVIOUR**

Adults caring for children in the provision are able to manage a wide range of children's behaviour in a way which promotes their welfare and development.

#### STANDARD 12 - WORKING IN PARTNERSHIP WITH PARENTS AND CARERS

The registered person and staff work in partnership with parents and to meet the needs of the children, both individually and as a group. Information is shared.

#### **STANDARD 13 - CHILD PROTECTION**

The registered person complies with local child protection procedures approved by the Area Child Protection Committee and ensures that all adults working and looking after children in the provision are able to put the procedures into practice.

#### **STANDARD 14 - DOCUMENTATION**

Records, policies and procedures which are required for the efficient and safe management of the provision, or to promote the welfare, care and learning of children are maintained. Records about individual children are shared with the child's parent.
