The purpose of this inspection is to assure children and young people, parents, the public, local authorities and government of the quality and standard of the service provided. The inspection was carried out under the Care Standards Act 2000.

## Service information

## **Brief description of the service**

This service provides short-break support for families with children who have learning difficulties who may also have a physical disability. The premises have been developed to provide accommodation and adaptations to support the children using this service. There are two adjacent lounge areas, a dining room, a kitchen, two bathrooms, office and storage space, a covered play area outside and garden areas. The home is situated in a residential area within travelling distance of a range of community resources.

## **Summary**

The overall quality rating is satisfactory.

This is an overview of what the inspector found during the inspection.

This unannounced interim inspection focused on the progress the service has made with the two actions and one recommendation from the last inspection. These related to children's care plans, staffing issues, and medication records. In addition, a specific focus has been taken on reassessing the key standards under staying safe. As a result of this inspection and meeting the action set the quality rating for staying safe is now good. The outcome areas; being healthy, enjoying and achieving, positive contribution, economic well-being and organisation were not looked at during this inspection.

The home has a long established staff team who are focused and committed to providing children with a high standard of care. They have a good understanding of how to support children with complex disabilities, and work well with parents and other agencies to ensure consistency of care. Staff remain highly committed to ensuring children are kept safe.

## Improvements since the last inspection

This inspection has been completed less than three months after the previous full inspection. There have not been any additional staff employed since the last inspection but the policy regarding the recruitment of agency staff has been revised to ensure that any agency staff used will have full employment histories. Addressing this staffing issue ensures that children are cared for by staff who are suitable; this gives children a good, positive experience while in their care.

Care plans are now updated more quickly following a significant event and senior management are now able to access care plans electronically to keep records up to date. This helps to ensure that children's care needs are always appropriately met.

The medication policy for the administration and security of drugs and medicines has

now been amended to clarify the need for an endorsement from an appropriate health professional on the occasions of removing medication from the original container. This will help ensure that there is no error in administration of medication to children receiving respite care.

#### Helping children to be healthy

#### Protecting children from harm or neglect and helping them stay safe

The provision is good.

The home provides an environment where children feel safe and secure. There are a range of policies and procedures available to promote and protect the welfare of children. Staff receive training in keeping children safe and this is updated at regular six monthly training events. They are very aware of the vulnerability of the children, and all children have a 'keep safe' plan. Staff are aware of the potential for bullying and accommodate children to ensure that bullying does not become an issue on short break visits. Group events and display boards are used to help children express themselves to ensure that children are kept safe and free from intimidation and bullying.

Children's privacy and dignity are highly respected and staff are sensitive to gender issues in particular relating to issues of personal care. Staff know the children very well and are able to ascertain their wishes and respect them. All staff are familiar with the confidentiality and privacy policy. Children's personal information is held securely and only divulged to others on a need to know basis and after consultation with parents. Information and guidance on the complaints procedures are readily available for parents and children. There have been no complaints since the last inspection, and children have opportunities to express their views through monthly meetings with an external facilitator and have access to a complaints procedure in appropriate formats.

Staff approach to children's behaviour is managed with sensitivity, and is child centred. Staff know the children well, they work closely with other carers and agencies involved with the child to ensure a consistent approach to managing behaviour. An external advisor and training refreshers ensure that children's behaviour management is reviewed and considered. This help children have an enjoyable time with clear boundaries to manage their behaviour.

Staff take positive steps to ensure that children are kept safe from harm while in the building and the grounds. Behaviour and activity risk assessments are undertaken as part of the process of placement planning and at the child's review to ensure the child lives within a structured and safe environment. There are comprehensive systems for monitoring equipment and utilities, and management systems to oversee

these. Regular maintenance is carried out on all appliances and services and when any defects occur there is a system in place to ensure that these are prioritised and quickly rectified, ensuring that the children have a suitable environment that is warm, safe and secure.

The home has not recruited any new staff since the last key inspection and procedures are now in place to ensure that agency staff are fully vetted. There are suitable arrangements for monitoring and managing visitors to the home. These procedures and arrangements help to ensure that those in contact with children are suitable.
