#### Introduction

This inspection was carried out by Ofsted under Sections 49 and 50 of the Childcare Act 2006 on the quality and standards of the registered early years provision. 'Early years provision' refers to provision regulated by Ofsted for children from birth to 31 August following their fifth birthday (the early years age group). The registered person must ensure that this provision complies with the statutory framework for children's learning, development and welfare, known as the *Early Years Foundation Stage*.

The provider must provide a copy of this report to all parents with children at the setting where reasonably practicable. The provider must provide a copy of the report to any other person who asks for one, but may charge a fee for this service (The Childcare (Inspection) Regulations 2008 regulations 9 and 10).

The setting also makes provision for children older than the early years age group which is registered on the voluntary and/or compulsory part(s) of the Childcare Register. This report does not include an evaluation of that provision, but a comment about compliance with the requirements of the Childcare Register is included in Annex B.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states if the provider continues to meet the requirements of registration.

### **Description of the setting**

The out of school club operates from Belle Vue Community, Sport and Youth Centre Hartlepool, and is run by Hartlepool Children's Fund. Children have access to a variety of rooms within the centre. There are no outdoor play facilities, so children use the large halls or visit the local park for physical exercise. Children attend the group from the local area and are usually referred by other childcare professionals. Children are collected from home and returned by staff at the end of the session. The group are registered to care for a maximum of 16 children between the ages of birth and eight years, currently there are no children on roll in the early years age range. The setting is registered on the Early Years Register and on both the voluntary and compulsory parts of the Childcare Register. The setting also care for children up to the age of 13. There are currently 38 children on roll. The group is open Monday to Friday from 8am to 7pm, and also operate through the school holidays. Four staff work directly with the children, all of whom hold a recognised childcare qualification from National Vocational Qualification Level 2 through to degree level.

### The overall effectiveness of the early years provision

Overall the setting meets the specific legal requirements. Staff demonstrate a friendly and caring attitude. The premises are clean and well-maintained with lots space for children to play. Staff discuss how this is complemented with trips to places of interest. Staff have a sound understanding of the Early Years Foundation Stage. The range of resources available and planned activities ensure all of the areas of learning are covered. Staff have a clear understanding of their role and responsibility with regard to safeguarding. Procedures are in place to carry out regular risk assessments within the setting and for outings, to reduce the risk of accidental injury. Staff show a positive attitude to providing an inclusive environment. This includes linking closely with parents and other professionals, in order to meet children's individual needs. Staff also show a good understanding of the benefits of liaising with other practitioners where children receive care and education in more than one setting, to ensure continuity and cohesion. All of the recommendations raised at the previous inspection have been positively addressed. This has a favourable impact on the quality of the service staff offer. Staff access a range of training, links with the early years advisor from the local authority have been developed and they implement procedures to evaluate their practice. This ensures continuous improvement is suitably maintained.
