#### Introduction

This inspection was carried out by three additional inspectors, who observed 16 lessons led by eight different teachers. Meetings were held with the senior staff, a group of pupils and the Chair of the Governing Body. Inspectors observed the school's work, and looked at safeguarding documentation and the school's analysis of its data. Questionnaires from 90 parents and carers, 24 staff and 110 pupils were received and analysed.

The inspection team reviewed many aspects of the school's work. It looked in detail at a number of key areas.

- Why do boys appear not to perform as well as girls, according to data?
- How consistent are teaching and assessment throughout the school?
- What is the impact of the monitoring carried out by senior staff on pupils' progress and attainment?

#### Information about the school

This school is smaller than most primary schools and serves a diverse community. The proportion of pupils from minority ethnic backgrounds is above average. A lower-than-average proportion of pupils speak English as an additional language. A lower-than-average proportion of pupils have special educational needs and/or disabilities. An average proportion of pupils are known to be eligible for free school meals. The Early Years Foundation Stage consists of one Reception class. The school has gained Healthy Schools status and the Activemark award. There is a privately run breakfast club and after-school club at the school that were not part of this inspection.

# **Main findings**

Kenley Primary School provides a satisfactory education for its pupils. As a result, pupils, including those with special educational needs and/or disabilities and those for whom English is an additional language, make satisfactory progress. However, there are a number of strengths in the school. Children get off to a good start in the Early Years Foundation Stage. Relationships between adults and pupils are good and this promotes pupils' willingness to make positive contributions around the school. Pupils are looked after well and this helps them to feel safe. They are adopting healthy lifestyles because the school emphasises this aspect effectively throughout the curriculum. Children from different backgrounds get on well together and learn to respect each other's differences. That is appreciated by all those parents and carers who completed the questionnaire; a typical view was expressed by one parent, who wrote `Kenley is not just a school, it is like an extended family. The teachers have positive relationships with children and parents.' Links with parents and carers are good.

Pupils' attainment at the end of Year 6 is broadly average. Attainment in reading is higher than in writing and mathematics. Although boys make similar rates of progress to girls, their attainment is not currently as high as that of girls; however, this gap in attainment varies between different year-groups of pupils. There are no significant differences in achievement between pupils known to be eligible for free school meals and other pupils, and between those who speak English as an additional language and other pupils.

Teaching and learning are satisfactory overall. Some teaching is good and engages and motivates pupils fully in their learning. Good relationships encourage pupils successfully to try hard to please staff. Technology is used well by staff as a valuable aid to make teaching clear to pupils. Planning indicates the main focus of lessons, but does not always show what pupils at different levels of ability are expected to learn in lessons. As a result, work is not always tailored to meet individual needs and this slows down progress. Marking is encouraging, but does not always provide enough guidance for pupils about how to improve and not enough opportunities are given for them to respond to suggestions made. Occasionally, pupils who are working independently are not given the guidance they need to ensure they make the progress of which they are capable. The curriculum is enriched by a wide variety of additional activities after school and visits to places of interest. However, pupils do not have enough opportunities to write at length in literacy and across the curriculum, or to record their work in mathematics and this slows down their

progress in these subjects.

The headteacher has a clear vision for the school and a secure awareness of the school's strengths and areas that need improvement. Monitoring and evaluation are mainly carried out by the headteacher. Senior staff have few opportunities at present to carry out their monitoring and evaluation roles and this limits the team's impact on teaching and learning across the school. Self-evaluation is generally accurate and key priorities for improvement are identified. That, along with the good relationships throughout the school, demonstrates the school's satisfactory capacity to sustain improvement.

Up to 40% of the schools whose overall effectiveness is judged satisfactory may receive a monitoring visit by an Ofsted inspector before their next section 5 inspection.

### What does the school need to do to improve further?

- Raise attainment in writing and mathematics by July 2012 by:
  - providing pupils with more opportunities to write at length in different subjects
  - providing them with more opportunities to record their learning in mathematics.
- Ensure greater consistency in teaching and assessment by April 2012 by:
  - indicating in planning what pupils at different levels of ability are to learn in lessons so that work can be tailored to meet individual needs
  - checking on the progress of pupils who are working independently and giving guidance as necessary
  - providing feedback in marking that indicates the next steps in pupils' learning and providing opportunities for pupils to respond to the suggestions made.
- Ensure the monitoring and evaluation carried out by senior staff lead to improved outcomes for pupils by:
  - training senior staff further in the techniques of monitoring and evaluation
  - providing opportunities for them to monitor and evaluate outcomes in their areas of responsibility.

# Outcomes for individuals and groups of pupils

Pupils' achievement is satisfactory, given that they start in Year 1 with skills levels that are broadly average and progress to the point where test results, as well as standards seen by inspectors in lessons and books, are broadly average. Pupils from all backgrounds, including those with special educational needs and/or disabilities and those who speak English as an additional language, are developing their basic skills satisfactorily and are well equipped with wider skills and personal qualities for

their future lives.

Pupils enjoy their work and settle down to it quickly. For example, in Year 6, pupils were fully engaged and responded eagerly as they identified key features in the life of Barak Obama. Year 5 pupils enjoyed greatly finding patterns in numbers from different multiplication tables. Year 4 pupils were excited and became animated as they told their partners the ending to the story they were about to write.

Pupils have a good knowledge and understanding about healthy eating and the importance of regular exercise. They enjoy physical activities in lessons, at playtimes and after school, which help promote their healthy lifestyles. The impact of the Healthy Schools status and the Activemark award can be seen by pupils' positive responses in their questionnaires. Pupils make a good contribution to the school and local communities. For example, pupils in Years 4, 5 and 6 act as reading partners for pupils from younger classes. Some act as `school ambassadors' and take part in initiatives such as mini-olympics with other local schools. Pupils collect for a variety of charities at home and abroad, including sponsoring a child in Ethiopia. Elected pupils represent their peers on the school council. Pupils reflect thoughtfully upon some of the broader issues in life, such as why harvest is so important for them and for people around the world.

# How effective is the provision?

Lesson preparation and classroom organisation are effective in enabling lessons to

flow smoothly. Teachers provide useful aids such as story maps and key words that help pupils to extend their writing, although opportunities for extended writing are often limited. Teachers and teaching assistants support pupils with special educational needs and/or disabilities and those for whom English is an additional language satisfactorily on an individual and/or group basis and this helps these pupils in their understanding of particular aspects of their work. The majority of teachers ask probing questions that identify precisely what pupils know already and what they need to know next. In the best lessons, teachers provide clear guidance by showing pupils what is expected of them. Occasionally, the introductions in lessons are too long for some pupils to sustain their concentration and the pace of learning in these lessons is not as rapid as in the best. That is particularly the case in mathematics, where the mental-maths starter and the main teaching for the lesson are on different topics. The impact of that is that pupils do not have enough time to consolidate their own learning on an individual basis.

The school provides a wide range of enjoyable experiences and opportunities for pupils, who talk enthusiastically about visits out of school to, for example, different places of worship, sea life and wild life centres, museums and Westminster Abbey. Pupils enjoy listening to visitors to school such as authors, the storyteller, artists and members of the emergency services. Out-of-school clubs are popular with pupils, as indicated by the high take-up for activities such as football, tennis, dancing, cooking, choir and recorder. Provision to promote pupils' personal development is included effectively throughout the curriculum. Pupils receive good opportunities to develop their skills in speaking and listening, but the match of work to pupils' different levels of ability is satisfactory rather than good.

Good arrangements for pupils joining the school ensure that they settle quickly. One parent who was pleased with induction procedures wrote `I have been particularly impressed with the way my son was introduced to school. Lots of settling-in opportunities, good communication, very welcoming and encouraging.' In replies to their questionnaires, nearly all pupils responded that they were looked after well by staff. Pupils with special educational needs and/or disabilities are identified effectively and suitable provision is allocated to meet their needs. Procedures for promoting attendance are good, as indicated by above-average attendance. Transition arrangements are good from the Reception class into Year 1 and from Year 6 to secondary school.

### How effective are leadership and management?

Morale is high because staff feel that their contributions are valued by the headteacher and senior leaders. There is a strong sense of pulling together to achieve goals because the headteacher, supported by senior staff, has satisfactorily instilled a sense of ambition and drive to improve the work of the school. Together, the staff and senior leaders identify strengths and weaknesses in provision and incorporate areas for development into plans of action.

The school has good relationships with parents and carers. Initiatives such as induction procedures, weekly newsletters, daily opportunities to chat to the headteacher at the beginning of the school day and to other staff at the end of the day all help to promote this positive relationship. Parents and carers are invited into school on a number of occasions, such as for consultation evenings, special assemblies and productions.

The effectiveness of the governing body is satisfactory. The governing body is supportive and enthusiastic for the school to do well. However, it does not challenge the school sufficiently to ensure pupils make good progress. Safeguarding procedures are satisfactory. Staff are vetted rigorously and close circuit television cameras have been installed around the site. The school has taken steps to tighten up on certain procedures to improve safeguarding further. Links with medical services and social services help to promote effectively the personal development and well-being of pupils and links with the local authority are having a satisfactory impact on outcomes for pupils.

The school promotes equality satisfactorily for the different groups and tackles any racist behaviour and discrimination effectively. That enables all groups of pupils to achieve satisfactorily. Community cohesion is satisfactory. Pupils have a good understanding of their local community and are developing their knowledge about national and international communities.

# **Early Years Foundation Stage**

Children join the Reception class with skills levels and abilities that are below those typically expected for their age in reading and writing. In other areas of learning, their skills and abilities are at expected levels. Children make good progress from their starting points in all areas of learning. Children with special educational needs and/or disabilities and those who speak English as an additional language make good progress also, in line with their capabilities, because they are supported effectively in small groups.

Children enjoy their learning and tackle their activities with relish and enthusiasm. They enjoyed building a house with large wooden blocks for the three little pigs while recalling the story about the wolf threatening to blow it down. They talked about how they made their Jack and the Beanstalk puppets and told this story in the puppet theatre. A particular strength of children's development is how well they tidy up after their activities and wash their hands ready for their lunch. Children are looked after well and are kept safe. They are given good opportunities to chat to adults about what they are doing. Children engage intently in activities that promote reading, writing, counting and creative play. They are challenged effectively at their different levels of skills and abilities. Behaviour is good and children get on very well with each other and with adults. The inside and outside learning environments are stimulating, child-friendly and well organised. They provide children with an enjoyable range of activities that help develop their understanding and skills in all areas of learning. The balance between adult-led and child-initiated activities is good. The Early Years Foundation Stage is well led and staff work well together as a team with a good understanding about early years' provision. Children's progress is monitored and recorded systematically in their 'learning journey' books. Links with parents and carers are good, as are induction procedures that enable children to settle quickly into school routines.

## Views of parents and carers

The views of parents and carers are very positive. Approximately one quarter of the questionnaires returned included written comments, most of which were positive. Written comments focused on the children's enjoyment of school, friendly and helpful staff, the quality of teaching, induction procedures and leadership and management. The views of parents and carers have been included throughout the report, but can be summarised by the one who wrote `Kenley is the perfect environment for my children. The staff are great and make learning fun. Parent and carer relationships are always outstanding as are child-teacher relationships.'

#### Responses from parents and carers to Ofsted's questionnaire

Ofsted invited all the registered parents and carers of pupils registered at Kenley Primary School to complete a questionnaire about their views of the school.

In the questionnaire, parents and carers were asked to record how strongly they agreed with 13 statements about the school.

The inspection team received 90 completed questionnaires by the end of the on-site inspection. In total, there are 204 pupils registered at the school.
