Service information

Brief description of the service

The unit is registered as a secure children's home, operated by the local authority and is approved by the Secretary of State to provide secure care and accommodation. Education is provided on site in dedicated school facilities. The unit provides secure accommodation for up to 24 young people.

Progress

Since their previous inspection the service is judged to be making **good progress**.

The service has made good progress with some positive developments identified since the last inspection. Two recommendations were made at the last visit and both have been suitably addressed.

A recommendation made at the last inspection regarding training in autism for the staff team has now been met. The training course for staff is designed and delivered by a relevant professional who possesses the suitable technical knowledge in this area of expertise. The course has been undertaken by the majority of the staff team; assisting them to understand and better support young people who have autistic spectrum related needs.

Following the last inspection, the home's approach around aspects of behaviour management has benefited from some development as recommended. A more defined approach toward using restorative justice as an alternative to sanctions is now in place. The approach is more creative and there is good evidence demonstrating that the staff team are giving increased consideration to the choices

they make around managing each young person's behaviour.

The effectiveness of behaviour management techniques are considered in a multi-disciplinary weekly meeting and recorded on the minutes. An aim of the meeting is to identify the approach most suited to each young person. Discussions with young people confirm that they have a very good understanding of the methods of sanctions used. They know what to expect, one young person said 'I was asked to write a letter of apology... it made me think more about what I'd done'. The consequence and effectiveness of disciplinary measures are recorded elsewhere and are not recorded in the restraint and sanctions log. The impact of this omission on young people is minimal, as outcomes in relation to behaviour management are good.

The approach to safeguarding young people continues to develop positively. Training has been extended to administrative staff and the practice of monitoring restraints using closed circuit television has extended to include a broader range of staff. This serves to promote the practice of peer review and create a positive culture of minimal physical intervention. Young people are further protected by the unit's recruitment procedures which now include the expectations of staff in relation to online social networking sites.

Careful attention is paid to monitoring the overall performance of the unit and detailed monthly reports are created. These provide extensive statistical information and identify trends and patterns through the use of graphs and bar charts. They provide an excellent visual record of events overtime. However, they neglect to give an analysis or assessment of the unit's performance through a narrative interpretation on a six monthly basis in line with good practice. An annual written report is produced at the end of each year which assesses the year's overall performance and this is used to set out development objectives for the year ahead.

Community links have been strengthened with young people's endeavours being shared with local residents. This includes an exhibition of young people's art work at the local library and donations to the local football team; both events are mentioned in local publications. These serve to promote the positive profile of the unit and instil a sense of pride in the personal achievements for young people.

 ensure that the manager regularly monitors, in line with the regulations, all records kept by the home to ensure compliance with the homes policies, to identify any concerns about specific incidents and to identify patterns and trend. In particular, ensure that a written report of monitoring activities is produced every six months and sent to Ofsted. (NMS 21.2)
