Reason for inspection

This unannounced emergency inspection, requested by the Department for Education (DfE), was made in response to a complaint regarding the condition of the premises. The complaint focused on a number of issues: the unhygienic state of the premises; rodent infestation; health and safety risks to the students; the unsafe nature of the premises during the continual building works and the presence of building personnel who might have access to the school.

Conclusions

Interviews were held with several teaching and support staff and one of the trustees. The headteacher was not present at school during the visit. A range of documentation was examined. This included the single central register, staff and student files, the attendance and admissions registers, the complaints book, health and safety records, including the recording of fire drills and risk assessments for both the students and activities taking place at the site. A tour of the premises was undertaken.

The premises are in a state of disarray with major building works still taking place, mainly on the ground and first floors. The presence of building works was noted in the inspection reports of March 2011 and September 2011. The school currently occupies the second and third floors only, while the rest of the building is still being refurbished. There are some building personnel on the premises. They are checked against criminal records by the building company and are strictly forbidden from entering the area occupied by the school while it is open.

The complaint focused on the general lack of cleanliness in the areas used by the school, the state of the toilets and the lack of fresh air and drinking water available to the students. The premises are adequate in size but some areas are in need of refurbishment; these include the floor covering leading from the stairs into the school area on both floors used by the school. Some areas of the school are in need of redecoration.

There are sufficient toilets. They are clean but there is neither toilet paper nor paper hand towels available except on request from the office. There is a sanitary bin and soap on only one floor while there are toilets on two floors. Most of the windows at the front of the building are covered in scaffolding and this has been the case for some time while the outside of the building is repaired and marble cladding added. The windows are as a result very dirty and they have not been cleaned for some time. Those adjacent to the scaffolding cannot be opened and these rooms lack fresh air. There is no fresh drinking water available to the students apart from that located in the toilet area.

There is now no evidence of a rodent infestation. There has been a rodent problem at the school in the past and a specialist company was called in to deal with the problem. There are no medical facilities for students who may be ill or showering facilities for students' use after physical education lessons. There are no outdoor play facilities and the students are taken to a nearby park only in the summer term for physical education and recreation. A new sports hall has been

installed recently at the school.

The school fails to meet a number of regulations to ensure students' welfare, health and safety. The school has carried out some risk assessments on specialist areas of the school such as the science room and for visits outside of the school. The building company have carried out a detailed risk assessment regarding their building works and the implications for the students' safety. The admission and attendance registers are not kept according to the regulations. Many of the attendance registers are kept in pencil, not ink as required, and the recognised codes for absence are not always used. The admission register is not up to date.

The procedures for appointing staff lack robustness, although a member of the support staff has trained in safer recruitment. The school fails to meet all the regulations relating to ensuring the suitability of staff because of the inadequacy of the single central register of staff checks. While it maintains such a register in a suitable format, the register is not up to date. It does not include a number of staff who currently work in the school. The staff files lack some of the required information. While some new staff have not yet had criminal record checks, they are not left in sole charge of students.

The school has a complaints procedure and confirms that it has received no complaints, but there is no system for recording complaints.

Information about this school

- Ayesha Siddiqa Girls School is an independent secondary school for Muslim girls. The school opened in April 2007 and is registered to admit up to 200 pupils between the ages of 11 and 16. There are currently 99 pupils on roll. The pupils are of diverse heritages and come from various parts of London. The vast majority are either bilingual or are at an advanced stage of learning English as an additional language. None has a statement of special educational needs.
- The school is situated in the centre of Southall, in the London Borough of Ealing, normally occupying two floors of the Islamic Centre. There was an extensive building and refurbishment programme taking place when the school was last visited. From September 2011 the school has occupied the second and third floors.
- The proprietors run the school as a charitable trust with a governing body and aim to provide an education for its pupils that conforms to the National Curriculum and incorporates religious teachings according to Islam. The school's last full inspection was in March 2011 and at that time it failed to meet a number of the regulations. A progress monitoring visit took place in September 2011 to check the progress the school had made in implementing its action plan. At that time the school was found to meet all the regulations for independent schools.
