## **The quality and standards of the early years provision**

### **The provision does not meet requirements**

- The childminder understands most of her responsibilities in safeguarding children and meeting the requirements of the Statutory Framework for the Early Years Foundation Stage to protect children's safety and welfare.
- The childminder is unable to provide evidence of a current paediatric first aid qualification which is a requirement of the Early Years Register and the Childcare Register.
- The childminder demonstrates an understanding of how to support children's learning and development appropriately. She describes how she intends to do this through using toys and activities both inside and out side the home.
- The childminder understands how to keep children safe and demonstrates through discussion how she will encourage their awareness of their own safety and good health. The childminder is aware how to use risk assessments to review and monitor safety in the home, and ensure the relevant precautions are in place when children are present.

## Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

## Inspection activities

- The inspector discussed with the childminder how she intends to deliver the education program when caring for children.
- The inspector viewed some of the childminder's policies and documentation she will use when caring for children.
- The inspector discussed with the childminder the process for self-evaluation and continual improvement.

## Full Report

### Information about the setting

The childminder registered in 2001. She lives with three foster children, all of whom are of school age. They live in Northolt, in the London Borough of Ealing. The children have use of the whole of the ground floor and the first floor of the house. There is an enclosed garden available for outdoor play. The family has goldfish as pets.

The childminder is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. There were no children in the early years age range on roll at the time of the inspection.

### What the setting needs to do to improve further

**To meet the requirements of the Early Years Foundation Stage the provider must:**

- ensure they hold a current paediatric first aid certificate.

## Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
