

Service information

Brief description of the service

This home is a specialised children's home that is provided by a private residential childcare provider in partnership with an independent mental health community service. The service provides residential care for children and young people who have experienced moderate to serious mental health problems. The home is registered to care for five children at any one time.

The inspection judgements and what they mean

Progress

Since their previous inspection the service is judged to be making **good progress**.

At the full inspection on 14 February2013 the home was judged to be good. The home has demonstrated continued improvement in the quality of care and outcomes for the young people. The one action, with regard to the recording of restraint, raised at the last inspection has been addressed. On this inspection an action has been made in respect of the recording of sanctions. There is no impact on the outcomes for young people of this deficit, so the overall judgement has not been affected.

Young people continue to make progress from their starting points, and are appropriately placed in the home. They commented positively about their care and the support they receive, and said that 'staff really care' and are 'lovely and treat everyone well'. Individualised care planning ensures that their individual needs are met, and they are safeguarded. Young people are routinely involved in their plans;, they add their comments and sign their plans and records. They gain from the home working with their parents and a range of professionals, to provide additional support

when they need it. Young people have successfully moved on from the home, due to the progress they have made. Some continue to visit, or are in telephone contact with staff.

Healthy living is well promoted and young people are involved in shopping and cooking, and follow their own dietary preferences. They are increasing their life skills, in line with pathway plans, where appropriate. The staff work effectively with mental health professionals, which ensures that young people receive high levels of support from specialist services. Young people are attending and achieving in education, and have made progress. They receive tuition and arrangements are made for them to sit public examinations. To help them make decisions about their on-going education, they have been given information or visited local colleges. Young people choose activities they wish to engage in, according to their wishes and interests.

Good relationships between the young people and staff underpin positive behaviour management, to which the young people respond well. The staff work in an open way to help them manage their feelings in more appropriate and safer ways. Staff are alert to young people's mood changes, provide appropriate supervision, and take actions to protect them when young people are unable to manage their own behaviours. The use of restraint is rare. Young people are consulted about recompense for their inappropriate actions, and sanctions are few. They rarely go missing from the home, and appropriate actions are taken to safeguard them as far as is possible, when they do so.

The manager and staff group are highly committed to meeting the needs of the young people and providing good quality care. They are well supported and trained to do so. Opportunities are in place for in-depth discussions about the young people, with specialist professionals. These meetings also provide for additional support to staff, which they value. Records are clear, safely stored, and demonstrate the progress young people are making. Visits carried out by the monitoring visitor take place regularly, and the manager monitors and audits practice and records. Significant events are notified to all the relevant people.
