Outcome of monitoring visit for provision judged as inadequate

An Ofsted inspector, Pauline Nazarkardeh, carried out a monitoring visit of your provision on 29/07/2013. This visit follows on from your inspection where the provision was judged to be inadequate.

Outcome of the visit

As a result of our inspection on 28/06/2013, we sent you a welfare requirements notice.

As a result of the inspection you were issued with welfare requirement notices requiring you to:

- ensure that continuous risk assessment covers all areas in the indoor learning environment that children come into contact with.
- ensure that all staff understand the safeguarding policy and procedure for reporting any concerns about children's safety or welfare to agencies with statutory responsibility without delay
- ensure that the kitchen is clean and suitable for the hygienic preparation of food for children
- ensure that people looking after children are suitable to fulfil the requirements of their role.

In addition you were also issued with notices to improve in relation to managing children's behaviour, risk assessment and the range of activities and experiences available to children.

Having considered all the evidence, the inspector is of the opinion that at this time the setting is making satisfactory improvement overall.

Overall effectiveness of the improvement and outcomes for children

Overall the progress made since the last inspection is satisfactory, the welfare

requirements notices have been met.

Changes have been made to the staffing of the nursery and to the management team responsible for the running of the nursery and for supporting staff development. The systems to protect children have been improved with the procedures for reporting safeguarding being made clear to all staff. A programme to address the training and development needs of staff has also been put in place.

The notices to improve have been given attention, plans have been put in place to improve the range of activities and experiences available to children. In addition the staff team have considered how to effectively manage children's behaviour.

Risk assessments are now in place and are specific to each area of the nursery. Improvements have been made in relation to the provision of food.

A further monitoring visit is to take place in order to assess the changes made following the inadequate inspection.

Next steps

Having considered all the evidence the inspector is of the opinion that at this time:

- The setting has made satisfactory progress in addressing the points for improvement. The next visit will be a further monitoring visit.
