The quality and standards of the early years provision

The provision meets requirements

- The manager and staff demonstrate a good knowledge of the safeguarding and welfare requirements and learning and development requirements and those activities that will help promote children's learning in all areas.
- Staff demonstrate they know and understand the safeguarding policy and procedures to follow to keep children safe. They confidently explain whistle blowing procedures and they complete detailed records when accidents occur.
- There are suitable procedures in place to check the suitability of staff and volunteers to ensure that only those suitable to work with children do so. Management are aware of the required staff to child ratios and how to deploy staff to meet the needs of children.
- Management and staff complete robust risk assessments to ensure that the club environment and resources are safe and secure. Entry is controlled and all visitors are greeted by a member of staff.
- There is an appropriate behaviour management policy in place that staff fully understand and implement consistently for all ages of children that attend. This ensures that children can learn about boundaries and any incidents are handled in a calm and consistent manner.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Information about the setting

RAZ Roses Activity Zone Ltd has been established since 1996 and was previously run by the local authority. The current provider took over the provision in 2011 and re-registered the provision in 2012 to include the care of children in the early years age range. The group operates from St. Mary's Centre in the Ladywell area of the London Borough of Lewisham. Children have access to three large halls and there is an office, kitchen and toilet facilities. Children are taken on frequent outings to a local park for outside play and on a range of other outings. The setting is registered on the Early Years Register and on both the compulsory and voluntary parts of the Childcare Register. There are 40 children on roll in the Childcare Register age range. There were no children on roll in the early years age range at the time of this inspection. The group offers care for children aged from four years who are attend reception class at school to twelve years old. Children attend Monday to Friday from 3pm to 6pm after school during term time and from 8am to 6pm during school holidays. There is a team of three staff who hold relevant childcare qualifications, including the manager who holds a degree in early years and the early years professional status.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
