#### The quality and standards of the early years provision

#### The provision does not meet requirements

- This inspection took place following notification to Ofsted of an accident at the club where a child sustained a serious injury. Ofsted carried out an unannounced visit and found there was no breach of requirements. The club carried out a full investigation, reviewed its risk assessment and put in place staff training for managing games.
- The inspection found that staff take children's safety seriously. They describe how they involve children in assessing risk and considering the potential consequences of their actions. The club's system for risk assessment is comprehensive to help to keep children safe.
- Staff work hard to create a relaxed, welcoming and inviting environment that is ready for the children's arrival. They provide an extensive and interesting range of resources that reflect all areas of learning.
- Staff demonstrate, through discussion, a good understanding of the importance of establishing friendly, supportive relationships with children. They are successful in achieving this with older children and appreciate the need to build these links with younger children.
- There are effective measures for sharing information about the club with parents so they are involved in their children's care, learning and development.
- Staff demonstrate, through discussion, secure awareness of their responsibility to safeguard the children who attend the club. They are familiar with the procedure they must follow in the event of any concerns about a child's welfare.
- There are effective systems in place to fulfil the learning and development requirements of the Early Years Foundation Stage and to support children to make good progress in their learning.
- The club does not make evidence available and easily accessible at inspection, to demonstrate that all staff are suitable to work with children, and have undergone checks through the Disclosure and Barring Service. This is a breach of requirement of

the Statutory Framework for the Early Years Foundation Stage and the Childcare Register.

#### Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the compulsory part of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

#### **Inspection activities**

- The inspector discussed how the club meets the Statutory Requirements of the Early Years Foundation Stage.
- The inspector spoke with the registered providers/club manager, staff and older children who were present during the inspection.
- The inspector looked at available documentation.
- The inspector viewed areas of the school environment that are used by the club.
- The inspector took account of the views of parents of older children.

#### **Full Report**

#### Information about the setting

The Hokey Cokey Club is one of two out of school provisions owned by Kids Time Ltd. The club is an established out of school provision and registered under its current ownership in 2012. The club operates from Holmesdale Infant School in Reigate, Surrey. Children have access to the school hall, a classroom, a large outdoor play area and an area of woodland within the school grounds. The club is registered on the Early Years Register and the compulsory part of the Childcare Register. Sessions are held each weekday from 3.05pm to 6pm during term time only. The club welcomes children with special educational needs and/or disabilities and children who speak English as an additional language. There are currently 48 children on roll. For the first two to three weeks of the autumn term the club operates a walking bus from Reigate Priory School. The club employs nine members of staff, including the two registered providers. One of the registered providers holds a Foundation degree and five other staff hold appropriate early years qualifications or are working towards a qualification.

#### What the setting needs to do to improve further

## To meet the requirements of the Early Years Foundation Stage the provider must:

ensure Disclosure and Barring Service records are accessible and available for inspection, including the disclosure reference number, the date the disclosure was obtained and details of who obtained it.

#### Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
