Outcome of monitoring visit for provision judged as inadequate

An Ofsted inspector, Kamaljit Kaur Jandu, carried out a monitoring visit of your provision on 25/09/2013. This visit follows on from your inspection where the provision was judged to be inadequate.

Outcome of the visit

As a result of our inspection on 15/07/2013, we sent you a notice to improve.

The notice of action to improve asked you to: ensure there is a regular two-way flow of information with other early years settings that children attend in order to find out about and support continuity in learning and development.

The additional action that you were required to take to improve related to the learning and development aspects of care for children. We asked you to: ensure that parents are provided with a short written summary of their child's development in the prime areas when they are aged between two and three years, identifying the child's strengths and any areas where their progress is less than expected; gain sufficient knowledge of the learning and development requirements in order to provide appropriate learning experiences for children and use information from observations and assessments more accurately to clearly identify the next steps in children's learning so every child makes suitable progress.

Having considered all the evidence, the inspector is of the opinion that at this time you are making satisfactory improvement overall.

To further improve the early years provision the registered person should:

 ensure that parents are provided with a short written summary of their child's development in the prime areas when they are aged between two and three years, identifying the child's strengths and any areas where their progress is less than expected (Statutory Framework for the Early Years Foundation stage: Learning and Development-assessment)

Overall effectiveness of the improvement and outcomes for children

A monitoring visit took place on 25 September 2013. The provider has not yet fully met the actions. Some steps have been taken to develop relationships with other early years settings that children attend and the provider is working to develop this further, for example she has contacted the reception class teacher at the school that one of the children attends to discuss the activities the child engages in, in order to develop this further at the provider's setting. She has arranged a meeting with the Early Years consultant to support her in developing her knowledge and understanding of the learning and development requirements, including observation and assessments to support children to make progress. She also intends to discuss the progress check between the ages of two years and three years so that she can provide parents with a short written summary of children's development in the prime areas of learning.

The following notice of action to improve is re-issued: ensure that parents are provided with a short written summary of their child's development in the prime areas when they are aged between two and three years, identifying the child's strengths and any areas where their progress is less than expected (Statutory Framework for the Early Years Foundation stage: Learning and Development-assessment).

In addition, further concerns were observed at the visit on 25 September 2013. The provider has identified risks to children from building materials that are on the driveway to the premises but has taken no action to remove or minimise this risk. Also, emergency evacuation of the premises was restricted because a pushchair was stored in the hallway. This means that children's safety is compromised. A Welfare Requirements Notice has been issued asking the provider to:

take reasonable steps to ensure the safety of children, staff and others on the premises in the case of fire or any other emergency, with specific reference to ensuring emergency evacuation routes are clear and free from obstruction at all times that children are on the premises(Statutory Framework for the Early Years Foundation stage: Safety and suitability of premises, environment and equipment)

ensure that the premises, including outdoor spaces, are fit for purpose by undertaking regular risk assessments and taking action to remove or minimise any risks identified, with specific reference to the building materials on the driveway (Statutory Framework for the Early Years Foundation stage: Risk assessment)

Overall the provider has made satisfactory progress in addressing the points for improvement raised at the inspection, the next visit will be a further monitoring visit.



Next steps

Having considered all the evidence the inspector is of the opinion that at this time:

• The childminder has made satisfactory progress in addressing the points for improvement. The next visit will be a further monitoring visit.
