The quality and standards of the early years provision

The provision does not meet requirements

- The childminder has not informed Ofsted of relevant information with regards to all persons over the age of 16 years who live on the premises. This is a breach of a requirement and compromises children's safety as not all adults have had the appropriate checks undertaken to ensure their suitability to be around children.
- The childminder demonstrates a satisfactory knowledge and understanding of the learning and development requirements of the Statutory framework for the Early Years Foundation Stage, how to promote the learning and development of young children, make assessments of their development and work in partnership with parents and other professionals.
- The drive for improvement is adequately demonstrated by the childminder. She has access to support from the local authority to help her to continue to develop and reflect on her practice.
- The environment is well resourced. There is a good range of toys and equipment for children of varying ages to independently access and support their development.
- The childminder has improved her knowledge and understanding of ensuring children are provided with a balance of healthy and nutritious snacks and meals.
- The childminder demonstrates sound knowledge of appropriate behaviour management strategies and the need to maintain records and keep them confidential.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector carried out discussions with the childminder.
- The inspector observed a range of documentation, including the safeguarding policy and procedure.
- The inspector observed the premises and resources.

Information about the setting

The childminder was registered in 1990 and is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her three adult children and the family's pet dog in Sheffield. The whole of the downstairs area, the bathroom on the first floor and the rear garden are used for childminding. The childminder is able to take children to a local playgroup and undertake visits to the local shops and park on a regular basis. She is able to collect children from local schools and pre-schools and is part of the local primary school's network of after-school care.

The childminder currently has no children on roll. She provides care all year round from 8am to 6pm, Monday to Friday, except for family holidays agreed in advance. The childminder receives support from the local authority.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage the provider must:

ensure Ofsted are notified of all persons aged 16 years or older who are living on the childminding premises.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
