The quality and standards of the early years provision

The provision meets requirements

- Staff demonstrates their understanding of safeguarding children by making sure non-vetted people are not left alone with children and by adhering to the setting's safeguarding policies and procedures.
- All required documents are maintained by the setting to make sure the children are kept safe when in their care. For example, registers are completed and they use registration forms to find out about children's individual needs.
- Staff carry out risk assessments on all aspects of the environment and regarding the care of the children, including using the large play equipment and resources inside. This enables staff to keep children safe.
- Staff demonstrate through discussion how they use the children's individual needs to meet their learning and development requirements.
- Staff demonstrate through discussion how they support children to learn right from wrong through appropriate behaviour management systems.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector looked through a sample of documents including registers, risk assessments and a sample of policies and procedures.
- At the time of the inspection the setting had no children on roll in the early years age range.
- The inspector spoke with the manager, a representative from head office and staff at appropriate times.

Information about the setting

KIDS Lady Allen Adventure Playground for children with special educational needs and/or disabilities has been operating since 1975. It registered with Ofsted in 2001. It is privately owned by a company called KIDS. The adventure playground is situated on the edge of Wandsworth Common in Battersea, in the London Borough of Wandsworth. It operates from purpose-built, single-storey premises, close to local transport links. The setting has a main playroom, a music room, soft play area, office, kitchen, laundry and toilet facilities. The main area of play is an enclosed outdoor adventure playground with a variety of fixed equipment.

There are currently 167 children on roll; of these none are in the early years age group. Children attend for a variety of sessions and the setting accommodates children aged from five up to 19 years.

The setting provides care for children with special educational needs and/or disabilities and also offers places to their siblings. It supports a number of children who speak English as an additional language and offers an open access scheme to the general public. The setting is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register.

The setting is open seven days a week during term time, with varied times and during the holidays, each weekday from 10 am to 4 pm. During the holidays, open access is from 10 am to 12 noon daily, and on Tuesdays from 10 am to 3 pm; this is for children under eight years and their parents. The setting employs 58 staff. Of these, three are permanent members of staff who work with the children and all have appropriate early years qualifications. The setting receives support and training from KIDS London and the local authority Children's Services Department.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
