## Outcome of monitoring visit for provision judged as inadequate

An Ofsted inspector, Nikki Whinton, carried out a monitoring visit of your provision on 18/11/2013. This visit follows on from your inspection where the provision was judged to be inadequate.

## **Outcome of the visit**

As a result of our inspection on 25/10/2013, we sent you a welfare requirements notice.

We also sent you five notices to improve. The welfare requirements notice required you to:

ensure that arrangements for safeguarding children are secure by following clear policies and procedures that are known and understood by all staff and implemented consistently, in order that statutory agencies are informed without delay of any allegations against staff.

ensure that the premises, in particular the areas used by babies, are fit for purpose, clean and safe and that staff comply with requirements of health and safety legislation (including hygiene requirements)

ensure staff implement the policy and procedures for assessing any risks to children's safety, identifying all aspects of the environment that need to be checked on a regular basis, including when and by whom those aspects will be checked, and how these risks will be removed or minimised.

The welfare requirements notice had a completion date of 17 November 2013.

The notices to improve required you to:

improve staff's knowledge of the learning and development requirements in order to

consider the individual needs, interests and stage of development for each child and use this information to identify their next steps and plan a more challenging experience for each child in all of the areas of learning and development (Planning)

foster a culture of mutual support, teamwork and continuous improvement by introducing a rigorous process of self-evaluation to effectively acknowledge strengths and identify weaknesses in the provision and develop a clear plan for improvement (Staff qualifications, training, support and skills)

ensure that all children receiving childcare are kept safe from harm (Welfare of the children being cared for)(compulsory and voluntary part of the Childcare Register)

ensure that a written statement of procedures is known to all staff and consistently followed for the protection of children, intended to safeguard all the children being cared for from abuse and neglect (Arrangements for safeguarding children)(compulsory and voluntary parts of the Childcare Register)

undertake a risk assessment of the premises and equipment: to ensure that all necessary measures are taken to minimise any identified risks (Suitability and safety of premises and equipment)(compulsory and voluntary parts of the Childcare Register).

The notices to improve have a completion date of 9 February 2014.

Having considered all the evidence, the inspector is of the opinion that at this time the setting is making satisfactory improvement overall.

To further improve the early years provision the registered person should:

#### Overall effectiveness of the improvement and outcomes for children

An inspector visited you on 18 November 2013 to monitor your progress. The inspector discussed with you the steps you had taken to address the actions raised in the Welfare Requirements Notice. The inspector spent time in the base rooms and scrutinising the environment, talking to staff and observing their interactions with the children.

You have ensured all staff have completed updated safeguarding training. Staff demonstrated that they now have a very secure understanding of their safeguarding roles and responsibilities. They know the correct procedures to follow if they have a concern, including the need to notify statutory agencies without delay of any allegations against staff.

You have reviewed and made changes to the environment. For example, areas of the nursery have been steam cleaned, electric socket points in the floor of the baby room have been covered, new display boards have been created, additional policies and procedures are displayed for parents and carers reference, some ceiling tiles have been replaced and potential hazards in the toilet area have been removed. However, at the time of the visit, nappy changing units and the milk kitchen wash hand basin were not hygienically clean and an item of baby food was not correctly stored.

You have reviewed and extended the setting's risk assessments in order that they are more comprehensive and individualised for each base room. Staff are now taking ownership for the risk assessments. They are aware of the need to complete and record daily risk assessments including for specific areas such as the milk kitchen and outside play space. However, staff are not consistently implementing the revised risk assessment procedures. As a result, some potential risks to children had not being identified and assessed or the risk removed.

### **Next steps**

Having considered all the evidence the inspector is of the opinion that at this time:

• The setting has made satisfactory progress in addressing the points for improvement. The next visit will be a further monitoring visit.


