The quality and standards of the early years provision

This provision is good

- Children make good progress from their initial starting points because of the wideranging opportunities available to them, and the valuable support from staff.
- Leadership and management are strong because the manager has a clear vision for the setting's good practices and parents are fully involved to provide consistency of care.
- The manager has ensured that staff have received comprehensive training to fully support their understanding of the setting's policies and procedures to record accidents to make sure the information is detailed.
- Interesting and stimulating activities and the good access between the indoor and outdoor environments enable children to choose where they wish to play and encourage their decision-making skills.
- Children enjoy strong relationships with staff at the nursery. Therefore, they are happy and keen to learn and rapidly grow in self-assurance.

It is not yet outstanding because

- Organisation during some mealtimes means children wait for long periods, which can result in them becoming restless.
- Staff are not consistent in fully promoting children's emerging language development.

Information about this inspection

Inspections of registered early years provision are:

Information about the setting

Lollipops Nursery at Bramble House was registered in 2002. It is a privately owned nursery operating from a three-story, detached house in New Eltham close to local shops, parks and New Eltham station. The nursery has an under two's unit on the ground floor and a nursery unit on the first floor. There is a fully enclosed garden available for outside play and a forest school forms part of available facilities.

Lollipops Nursery is registered on the Early Years Register and there are currently 55 children on roll. The nursery is in receipt of nursery education funding for children aged two, three and four years. Staff care for a number of children with special educational needs and/or disabilities and those who learn English as an additional language.

The nursery opens five days a week, all year round, and children can attend on a part or full-time basis. The nursery opens from 7.45am to 6.15pm.

There are 12 staff working with the children, 10 of whom, hold relevant early years qualifications. Two staff, including the manager, hold an early years degree. The nursery staff follow initiatives such as the 'Every Child a Talker' programme and the Forest School education philosophy.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- strengthen routines at mealtimes to reduce times children are waiting for food
- improve the way in which staff model using descriptive words with the children in order to promote children's language development further.

Inspection judgements

How well the early years provision meets the needs of the range of children who attend

The quality of teaching is good; as a result, children are progressing well towards the early learning goals. Planning is effective in helping children make good progress in their learning and development. Staff use the children's next steps in learning, their interests and views from the parents to plan effectively. Staff track the children's progress using appropriate guidance. This is used successfully to identify whether children require any support or extra challenge in their learning experiences. Parents are invited into the nursery to talk with the staff about their children's progress and to share with them what they have been doing at home. This provides good continuity of care for the children.

Detailed progress reports and the required progress checks for two-year-old children are shared with the parents. This enables them to see the progress their children have made.

Staff provide a good standard of childcare by creating a safe and enriching environment where children can play, learn and develop to the best of their ability. Learning is promoted well because staff provide a good range of activities and experiences covering all areas of learning. This effectively supports children, as activities are interesting and individualised to meet specific learning needs. Overall, children are prepared well for the next step in their learning. However, staff are not consistent in modelling descriptive words with the children during some activities. Staff do ask children useful questions, which promotes their emerging language skills well overall. Staff use sign language to teach children of all ages how to communicate non-verbally to support the inclusion of children with particular needs. This greatly supports children's self-esteem and their confidence to express their needs.

Children of all ages enjoy reading books and readily choose their favourites to read with the staff. Staff ask children useful questions about what is happening in the books. This allows children to think about the answers as they develop good early reading skills. Staff encourage children to write their names on their creations and praise them for their efforts. Some children confidently spell their names and write letters to show staff what they can do. These opportunities help to promote children's early writing skills well.

Staff effectively promote children's physical development as they play in the wellresourced indoor and outside environments. Children are able to use the main garden, the sensory garden and the forest school area to enhance their physical development. Staff work closely with the younger children to ensure they are able to explore the outside play areas and to enhance their physical development.

The contribution of the early years provision to the well-being of children

Staff demonstrate a very positive approach towards inclusion. They work closely in partnership with parents to fully understand and meet the individual needs of all children. This helps to successfully to settle them into the nursery. Staff show a comprehensive understanding of each child's unique needs and have detailed information on child record forms of their individual requirements. A variety of resources and displays around the base rooms depict positive images of diversity, including those of culture, gender and disability. Children celebrate a variety of festivals and cultural celebrations throughout the year and these are reflective of children's cultural backgrounds. This allows children to learn about different customs and celebrations of their friends and the wider world in which they live.

The setting has effective measures to promote children's ongoing safety in the nursery, as well as on outings. Risk assessments are thorough and clearly identify hazards and any action taken to minimise these to keep children safe. Staff carry out fire drills on a regular basis, teaching children to be aware of what to do in an emergency. Children enjoy valuable social experiences when eating together. The majority of children help themselves to their cutlery and drinks, which supports their independence skills and

physical development well. Staff sit and talk to the children about what they are eating and the effect it has on their bodies. Staff support the children well in learning about portion control and all children are developing good levels of control when serving their meals. However, the organisation in some rooms at mealtimes leaves children waiting for long periods while their food is collected and cools down. As a result, some children start to get restless.

All staff are consistent in their approach to behaviour management. They teach children about the clear and concise boundaries in place and the children show that they fully understand them. The staff also work closely with the local authority and other agencies to provide support for the staff in dealing with children who have special educational needs and/or disabilities. They set achievable goals and meet regularly with parents and the agencies caring for the children to ensure they are meeting all their individual needs. Good strategies are in place to teach the children how to work together. Given the children's ages and stages of development they all behave very well.

Staff support children well as they move between base rooms and carry out these moves according to the children's individual needs. This ensures they settle well and can continue to make good progress with their learning and development. When children are nearing school age, staff work closely with the teachers to enable them to settle into a new routine quickly. This enables children to be ready for the next stage of learning. Children show that they feel emotionally secure. For example, they enjoy snuggling into staff when they feel tired or need reassurance.

The effectiveness of the leadership and management of the early years provision

Leadership and management of the setting are strong. The manager and staff work closely with the parents to bring about the best possible outcomes for all the children. Documentation is maintained to a good standard and all records required for the safe and efficient management of the setting are readily available. Staff implement a comprehensive range of written policies and procedures. These are regularly updated to reflect changes in legislation and to clearly underpin staff practice in promoting children's welfare.

Robust recruitment procedures are in place, which include checking the suitability of all staff. Staff have regular supervisions, one-to-one supervisions and appraisals to assess their work and to look at further training opportunities. The nursery closes for one or two inset days for staff to have further training. Most staff are well-qualified and also attend regular training, through the local authority, to enhance practice and promote children's learning and welfare. The manager has a clear understanding of the learning and development requirements. Staff plan and provide a good range of experiences for children in all areas of learning and staff monitor their progress well. As a result, children make good progress in their learning.

Self-evaluation is strong and clearly shows the key strengths of the provision and the

areas staff are currently working on. For example, the provider has met an action set at a previous visit by improving systems for recording accidents to promote children's welfare. The parents share their views as part of self-evaluation practices and the manager gathers the views of the children. This shapes the service provided, which is highly responsive to its users.

All staff have a strong understanding of child protection and how to safeguard the children in their care. All safeguarding requirements are met effectively. All staff know and consistently implement the Local Safeguarding Children Board procedures. Robust risk assessments are in place for both the premises and for all outings the children undertake. Children are well supervised across all areas of the setting and when on outings.

Staff work closely in partnership with the parents. Parents regularly share with the staff what they have been doing at home, which is used very successfully by staff to enhance the children's individual needs. Staff complete detailed developmental reviews on the children so parents can see the progress they are making. Detailed daily books allow the parents to see what the children have been doing during the day. This provides good continuity of care.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
