## The quality and standards of the early years provision

### The provision does not meet requirements

- Management and accountability within the club are not clear. As a result, practitioners who take the role of acting manager when the manager is not in the setting do not have a clear understanding of their responsibilities.
- Some areas for improvement have been identified and acted upon; however, the recommendation relating to observations and assessment made at the last inspection has not yet been addressed.
- There are good arrangements for involving children in planning the activities.
- Practitioners understand how to establish secure relationships with children, and older children have good relationships with each other.

## Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

## Inspection activities

- The inspector observed activities in the main playrooms.
- The inspector held meetings with the managers of the provision and the registered person.
- The inspector looked at children's planning documentation.
  - The inspector checked evidence of suitability and qualifications of practitioners working with children, the provider's operational plan, and discussed their self-evaluation.
- The inspector took account of the views of parents from information included in the setting's own evaluations.

## Full Report

### Information about the setting

Chantreyland Out-of-school Norton Free was registered in 2006 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. It is situated within Norton Free Primary School in the Norton area of Sheffield, and is managed by Chantreyland Childrens Nursery Partnership. The club serves the local area and is accessible to all children. It operates from two rooms and there is an enclosed area available for outdoor play.

The club employs four members of childcare staff. All of these hold appropriate early years qualifications at level 3. The club opens Monday to Friday during term time from 3.20pm until 6pm. Children attend for a variety of sessions. There are currently 30 children attending. There were no children in the early years age range on roll at the time of the inspection.

### What the setting needs to do to improve further

**To meet the requirements of the Early Years Foundation Stage the provider must:**

- make management and accountability arrangements clear to ensure practitioners who are involved in the management of the club, have a clear understanding of their roles and responsibilities.

## Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages.
