The quality and standards of the early years provision

The provision meets requirements

- The inspection was brought forward by Ofsted following failure of the childminder to notify of a conviction received by a household member living at the childminder's premises. An unannounced visit in February by Ofsted resulted in a initial warning letter being issued.
- The childminder has an enabling, well-resourced environment both inside and outdoors that will fully promote children's independence and creativity.
- The childminder demonstrates a good understanding of how to carry out observations and assessments. She explains how this information would be used to plan the next steps for children's development and learning. The childminder explains how she would engage parents in their child's learning and development, so that children can benefit between home and the setting.
- The childminder demonstrates a sound awareness of child protection procedures and recognises the possible signs of abuse. She ensures her home is safe and that children are kept safe during outings by completing risk assessments of her home and any outing that occurs. The childminder ensures that all people in contact with children are suitably and appropriately checked.
- The childminder has all the required documentation in place to promote children's safety and welfare. She explains how she would follow children's routines from home in order to help children to make a smooth transition into the setting.
- The childminder demonstrates, through discussion and sharing relevant documents, a suitable awareness of the Statutory framework for the Early Years Foundation Stage. This includes notifying Ofsted of significant incidents and changes to the provision. Ofsted are now satisfied with the childminder's ability to ensure that all people in contact with children are suitably and appropriately checked.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector toured the premises and viewed the play equipment.
- The inspector discussed with the childminder how she intends to deliver the educational programmes.
- The inspector viewed evidence of the qualifications of the childminder and a sample of policies and documents.

Information about the setting

The childminder was registered in 2003 and is registered on the Early Years Register and on both the compulsory and voluntary parts of the Childcare Register. The lounge, kitchen and the first floor bathroom of the childminder's house is used for childminding purposes. There is an enclosed garden available for outside play. The family have two cats and a dog.

The childminder lives with her adult daughter in Braunstone in the city of Leicester. She takes and collects older children from a local school. The childminder holds an early years childcare qualification at level 3 and is a member of the Professional Association of Childcare and Early Years.

At the time of the inspection there were no children on roll in the early years range.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
