Service information

Brief description of the service

This children's home is registered to provide care and accommodation for up to three young people with emotional and behavioural difficulties. The home is privately owned.

The inspection judgements and what they mean

Good progress	The children's home has demonstrated continued improvement in quality of care and outcomes for children and young people and where appropriate has addressed all requirements and the large majority of recommendations that were raised at the previous inspection.
Satisfactory progress	The children's home has maintained quality of care and outcomes for children and young people and where appropriate has addressed all requirements and the majority of recommendations that were raised at the previous inspection.
Inadequate progress	The children's home has failed to address one or more requirements and/or has not met the majority of recommendations and/or the quality of care and outcomes for children and young people have declined since the last full inspection.

Progress

Since their previous inspection the service is judged to be making **inadequate progress**.

At the last inspection in May 2013 the home was judged adequate with three statutory requirements and four recommendations. Only one requirement has been met and two of the previous recommendations have been escalated to statutory requirements as a result of this inspection. Progress has not, therefore, been adequately maintained.

This home has inconsistent care practice and overall lacks effective leadership and management. There has not been a Registered Manager in place for over 30 weeks. The present manager has yet to submit a fully completed application form to Ofsted. The present manager does have the required qualifications and experience although has yet to be assessed through the registration process. This meets one of the previous requirements.

Young people say they like the staff and that they are respected and valued. Young people are able to pursue recreational interests such as attending local youth clubs, football teams or going to the gym. This is an improvement since the last inspection.

Most of the staff do not have sufficient training, skills, knowledge or experience of caring for young people with emotional and behaviour difficulties. For example, a high level of police action has recently taken place which indicates that staff have not been able to manage challenging behaviour in a consistent way. Staff, therefore, are not competent to promote the welfare and to safeguard young people adequately.

Education, employment and training is inconsistently promoted within this home. For some young people this means that their days are without structure, interest or value. This leads to some young people staying in bed for long periods of time during the day. For some young people there is little or no progress since their placements began.

Young person are aware of the placement plans and are able to contribute to them. This is an improvement since the last inspection.

Supervisory arrangements for the manager of this home are insufficient. The line management of the current manager does not reflect the level of competence, skill and knowledge of residential child care required. This impacts on the quality, safety, outcomes and overall leadership and management of the home.

Children repeatedly go missing from this home. The arrangements for the protection of young people is compromised by poor interagency working practice and lack of overview of the missing from care procedures by suitable local agencies. There is no formal protocol between this service and the police force. This has the potential to put young people at risk of significant harm.

Serious events which have necessitated calling out the police have not been notified to Ofsted. The regulator is therefore, unable to assess the potential risks within the home between inspections.

The outcome of this inspection is that a further three requirements have been made in reference to promotion of welfare, competency of staff and safeguarding young people who are missing from the home. This impacts of the progress of young people in the care of this home.

Areas for improvement

- ensure suitable arrangements exist for professional supervision of the registered person of the agency. (NMS 19.3)
