Monitoring for provision judged as inadequate

An Ofsted inspector, Kelly Eyre, monitored your provision on 10/02/2014 following your inspection where the provision was judged to be inadequate.

Outcome of monitoring

As a result of our inspection on 14/11/2013, we sent you a notice to improve. The actions you were set are included at the end of this letter.

During the monitoring visit the inspector talked with the nominated person, who is also one of the managers of the pre-school, and with the second manager. The discussion was about the steps taken in order to address the actions raised in the notice to improve. She observed activities and staff interaction with children, both inside and in the outdoor play area. The inspector looked at your records of staff recruitment and the checks carried out to ensure the suitability of committee members. The inspector also looked at action plans, children's assessment records and activity planning.

The inspector found that the managers have worked together to develop a practical action plan to support you in addressing the issues raised at your last inspection. Your pre-school also has an appropriate self-evaluation process, enabling managers to review daily practice and the impact this has on the outcomes for children. This has further supported them in looking at how to address the areas for improvement identified at your last inspection. The inspector noted that their ongoing evaluation process helps to ensure that any improvements made are sustainable and continue to improve the provision for children.

The pre-school's recruitment policy has been reviewed and updated and all staff records have been checked to ensure that they contain relevant information. Appropriate checks have been carried out on all committee members to make sure that they are suitable. All records have been suitably stored and you have ensured

that they are available for inspection. In addition to this, you have introduced a procedure whereby all committee members are clearly aware of their roles, with appropriate guidance for new committee members. These measures enable you to ensure that the suitability of staff and committee members is appropriately checked, thereby helping to promote children's welfare.

The managers have started a procedure which enables them to monitor the progress of individual and groups of children attending the pre-school. This supports staff in identifying any areas where children require additional support. They have also adapted the planning procedures so that staff are now able to identify children's next steps and feed these directly into the planning. This enables the pre-school to better support each child's learning and development.

Managers and the pre-school staff demonstrate a positive approach to their work and have actively used the support offered by the local authority. To this end, they have all attended additional training so that they are now more aware of how to adapt activities so that these meet children's needs and offer them each appropriate challenge. As a staff group, they have started to use their new knowledge in their daily work with children and this now requires a consistent approach over time.

Having considered all the evidence, the inspector is of the opinion that the setting has taken prompt and effective action to address the points for improvement.

Next steps

The next step will be a full inspection.
