Monitoring for provision judged as inadequate

An Ofsted inspector, Elizabeth Juon, monitored your provision on 04/02/2014 following your inspection where the provision was judged to be inadequate.

Outcome of monitoring

As a result of our inspection on 10/12/2013, we sent you a welfare requirements notice. The actions you were set are included at the end of this letter.

In order to meet requirements relating to 'child protection' and 'safety and suitability of premises, environment and equipment', you were required to update your knowledge of child protection in order to understand possible signs and symptoms of abuse and neglect in order to identify these at the earliest opportunity and enable a response to be made in a timely and appropriate way; and provide a safe environment by risk assessing hazards to children's safety, with particular regard to the security of the premises, and taking preventative measures to ensure children's safety is prioritised

In addition, a notice to improve was also issued identifying further actions to be undertaken to ensure the welfare of children relating to 'child protection' to ensure you have and implement a policy and procedure, to safeguard children that includes and covers the use of mobile phones and cameras in the setting

Some actions that were set have a longer time frame by which to be completed. These will be monitored at the next monitoring visit. These relate to 'staff qualifications, training, support and skills', and the areas of 'learning and development and assessment'.

At the monitoring visit carried out on 4 February 2014, we found that satisfactory steps have been taken to address the priority actions identified in the welfare requirement notice. The provider has taken action to develop their knowledge and understanding of safeguarding and child protection by completing an online safeguarding course. There is a written child protection policy and procedure which includes the use of mobile phones and cameras in the setting. The local authority Early Years advisor has provided additional information on safeguarding children and the contact telephone numbers to enable a timely referral should concerns arise. The

provider has reviewed the safety of the premises to ensure children cannot leave the premises and no one can enter without their knowledge, to ensure children's safety.

An initial start has been made to meet the learning and development requirements but additional time has been allowed to enable improvement in this area. The provider has begun to make observations of children but needs to link the observations to an area of learning and provide the next step to help children progress. The Early Years advisor has provided advice and information on how to complete the written 2-year progress check. However, the improvement of the educational programme is still at the very first stages and the provider must continue to develop her understanding of the requirements over the next few weeks. The provider will be supported further by the local authority Early Years team and able to access appropriate training to help develop working practices and a system to self-evaluate the quality of the care and learning on offer.

The next monitoring visit will assess the progress that has been made and whether the improvement has been maintained.

Having considered all the evidence, the inspector is of the opinion that the childminder has taken prompt and effective action to address the points for improvement.

Next steps

The next step will be further monitoring.
