Monitoring for provision judged as inadequate

An Ofsted inspector, Dianne Adams, monitored your provision on 19/02/2014 following your inspection where the provision was judged to be inadequate.

Outcome of monitoring

As a result of our inspection on 28/11/2013, we sent you a notice to improve. The actions you were set are included at the end of this letter.

During the monitoring visit the inspector discussed with you the steps you have taken to address the actions raised in the notice to improve. The inspector also spoke to a representative from the local authority. She looked at the your risk assessments, observation, assessment and planning records, complaints procedure and self-evaluation.

The inspector found that you have a clear and concise action plan to support improvement and address the issues raised at your last inspection. You have prioritised children's safety and implemented clear risk assessments of the indoor and outdoor environment. For example, you have removed all debris from the garden and have placed architrave around the door frame of the kitchen, so that children cannot access exposed building materials. You have also shortened hanging blind cords around the premises and removed a free standing mirror from the bathroom. This ensures children now access an environment that is safe and protects their well-being. In addition, you have assessed and minimised the risks to children when on outings. In doing so, you now ensure children are kept safe by carrying first aid equipment with you and a book detailing the contact details of children's parents, in case of emergency. The inspector also found that you demonstrate a suitable understanding of the complaints procedure. You have implemented a clear and concise written policy which you have made available to parents.

You have welcomed support from the local authority and the inspector found that you are in the process of developing your practice to fully support children's learning. You have recently made changes to the way you observe, assess and plan for children's learning. You now complete regular observations of children at play which you clearly record in their individual 'Learning book'. You are using the information gained to monitor and plan their next steps in learning towards most of the early

learning goals. You are also improving the two-way communications with parents and other providers, when children attend more than one setting. For instance, parents inform you of what their children have achieved at home which you place on the 'proud cloud', displayed on the wall. You also obtain information from parents about children's likes, dislikes and interests, which you record in the 'Learning book'. To improve the cohesion and consistency of children's learning you are developing strategies to exchange information between yourself and the nursery school some children also attend. For example, the nursery school now gives you a copy of the child's observation and assessment record and you have plans to further improve communications through regular verbal discussions with the child's key person.

Having considered all the evidence, the inspector is of the opinion that the childminder has taken prompt and effective action to address the points for improvement.

Next steps

The next step will be a full inspection.
