The quality and standards of the early years provision

The provision meets requirements

- The childminder has a good knowledge of the learning and development requirements of the Early Years Foundation Stage. She has considered how to plan for individual children's needs through offering activities that reflect their interests and that are suitable for their unique stage of development.
- The childminder is aware of the importance of working in partnership with children's parents to seek information from home about their interests and progress that can be used to inform the planning of activities for their child.
- The childminder is aware of the importance of sharing information with parents about her policies and procedures in relation to safeguarding, behaviour management and how to make a complaint. She has procedures for providing feedback to parents each day about their child's activities and care routines including their meals and nappy changes.
- The childminder's home is welcoming and safe for the children. For example, children are safe because the front door is kept secure. There is a wide range of books and play materials that are accessible to children which cover the seven areas of learning for children of different ages. The childminder is aware of the importance of modelling appropriate behaviour towards the children.
- The childminder demonstrates a suitable understanding of how to safeguard children. For example, she describes how she supervises the children at all times. She carries out risk assessments and is well versed in what to do should any concerns arise about a child in her care. The adults in the household have the required clearances in place and the childminder holds a current first aid certificate.
- The childminder now has a good knowledge and understanding of what is required to be notified to Ofsted, such as informing of any changes to the persons working on the premises.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector discussed with the childminder how she intends to deliver the educational programmes for children.
- The inspector looked at policies and documents the childminder will use when she is caring for children.
- The inspector checked evidence of the suitability of the adults in the household and discussed the changes the childminder has made since the last inspection.

Information about the setting

The childminder was registered in 2012 on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her partner and three children aged three years, two years and five months in a house in Peterborough, Cambridgeshire. The whole of the childminder's home is used for childminding and there is an enclosed garden for outside play. The family has a cat.

The childminder attends a toddler group and activities at the children's centre. She visits the shops and park on a regular basis. The childminder operates all year round from 7.30am to 6pm, Monday to Friday, except bank holidays and family holidays. She is a member of the Professional Association for Childcare and Early Years. There were no children on roll at the time of this inspection.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments. It assesses council children's services, and inspects services for looked after children, safeguarding and child protection.
