The quality and standards of the early years provision

The provision meets requirements

- The management team demonstrate a sound understanding of the importance of evaluating the provision to ensure ongoing improvements are implemented, in order to support children's well-being, safety and learning.
- The staff demonstrate an appropriate knowledge of how to support children's care routines and their learning across the seven areas of learning and development.
- The environment is effectively maintained to keep children healthy and safe from harm.
- Partnerships with parents and other provisions are implemented well to support children's all-round development.
- The provision is organised well to ensure that children of different ages and abilities can access a varied range of resources, to support their learning indoors and outdoors.
- Staff have a good understanding of how to safeguard children because there is a clear policy and procedures to follow.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector sampled a range of documentation, including policies and procedures available.
- The inspector observed the safety of the provision indoors and outdoors.
- The inspector checked evidence of suitability and qualifications of staff working with the children.
- The inspector discussed with the staff how they deliver the educational programmes for children within the early years age range.

Information about the setting

Elland Out of School Club has been registered since 2005 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. It operates from All Saints Parish Church, Elland West Yorkshire. Children are accommodated in two rooms with access to an outdoor area. The building has disabled access.

There are currently 19 children on roll, two of whom are in the early years age range. There were no children present in the early years age group at the time of the inspection. Children attend for a variety of sessions. The club is open from 7.30am to 8.45am and from 3.15pm to 6pm during term time. There are four members of staff who work with the children on a full- and part-time basis. All the staff hold a relevant childcare qualification at level 3 or above. The setting receives support from the local authority.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
