Monitoring for provision judged as inadequate

An Ofsted inspector, Jan Burnet, monitored your provision on 31/03/2014 following your inspection where the provision was judged to be inadequate.

Outcome of monitoring

As a result of our inspection on 07/01/2014, we sent you a notice to improve. The actions you were set are included at the end of this letter.

During the monitoring visit the inspector discussed with you the steps you have taken to address the actions raised in the notice to improve. She observed you working with children, viewed resources available to children and had a discussion with you about current processes for observing children and assessing their progress. She discussed with you the welfare, learning and development, and assessment requirements within the Statutory framework for the Early Years Foundation Stage. You demonstrate that you are aware of requirements with regard to working with an assistant and you are aware of information that must be shared with Ofsted. The inspector looked at required documentation and records.

The inspector found that you have satisfactorily addressed the welfare requirements with regard to ensuring that consent is obtained from parents for children to be left in the care of an assistant for very short periods of time. She established with you that you are aware that this period of time must not exceed two hours. You are aware that Ofsted must be informed of any serious injury or accident to a child.

The inspector found that although you have not yet met with a representative from the local authority, you have begun to address requirements with regard to observing children and assessing their progress. To this end, you completed training on observation, assessment and planning on March 24th 2014. You have begun to include more detail in your written observations, however, you identify that planning for the next steps in children's learning is not yet embedded in your practice. You currently provide a basic 'all about me' document for new parents to complete with regard to their child's starting points in learning and explain that you also talk with parents about what their child knows and can do. However, you identify that your questions should be improved so that they are more focussed, particularly around the prime areas of learning so that this aids you better in making your own initial

assessment on children's learning and development. You explain that information on children's progress is shared regularly with parents verbally, to help them support children's learning at home. Parents are aware of the records that you keep. The inspector found that you are aware of the seven areas of learning and that you are using guidance documents to track children's progress and to improve your practice. You explain your intention to seek help from the local authority representative with regard to planning for the next steps in each child's learning and development. You explain to the inspector that you are considering how to effectively address continuity of learning for children between yourself and other early years providers.

Having considered all the evidence, the inspector is of the opinion that the childminder has taken prompt and effective action to address the points for improvement.

Next steps

The next step will be a full inspection.
