# **Service information**

### **Brief description of the service**

This children's home is part of a large national provider and is located in a rural setting. The home is registered to provide care and accommodation for up to two children with emotional and/or behavioural difficulties.

# Progress

Since their previous inspection the service is judged to be making **satisfactory progress**.

At the full inspection in May 2013 this children's home was judged good. Since then the home has made satisfactory progress overall with good outcomes achieved by children and young people.

This is a well-managed home. The staff team work effectively together to provide care and support that meets individual needs. Good emphasis is placed on ensuring admissions to the home are appropriate, both in terms of staff being suitably skilled to meet assessed needs but also in relation to young people being compatible with each other. The manager is fully aware of changes in legislation that is affecting children's homes. He has already commenced a Diploma Level 5 qualification and has made a full assessment of outstanding training needs amongst the staff team.

Young people were extensively consulted during this inspection. Without exception all of their comments were extremely positive. One young person described the home as 'amazing' and 'the best children's home' they had experienced. Other positive comments related to the great relationship young people enjoy with staff and the range of activities they enjoy. For example a recent project has been the construction of a hen house and run in the home's extensive grounds. Young people said that they feel safe at this home and recognise the progress they have made.

At the last inspection three requirements were made. These related to important information about the home and the quality of the review of care undertaken by the registered manager. In respect of the Statement of Purpose, there have been ongoing discussions between Ofsted and senior managers in the company to ensure that this document fully meets legislative requirements. At the time of this inspection a further revised version was being produced by the home. It was agreed a copy would be forwarded to Ofsted. An improved young person's guide has also been produced since the full inspection. This is more child-friendly and can be easily adapted to ensure it is suitable for the differing needs of young people who are admitted to the home. The final requirement related to improving the manager's review of care. This process and the resulting report has been reviewed and improved and demonstrates better evidence of appropriate consultation with young people, parents and social workers. This means that important views are properly taken account of and contribute to further improvements in the home.

Four recommendations were also made at the full inspection. Since then the home has seen several improvements to the physical environment. The kitchen-diner has been fully refitted and redecorated and now provides a very functional and sociable space. The young people's bathroom has also been upgraded and new carpets fitted in their bedrooms. While the home has also been recently redecorated, there was some damage to a bedroom door frame and paintwork noted. Furthermore the roof has not yet been repaired and continues to leak and is causing unsightly damage to the internal ceiling on the bedroom landing and office. This matter is now included as a requirement of this inspection report. Other recommendations that were made in relation to advocacy, individual protocols and deputising arrangements have been fully addressed.
