The quality and standards of the early years provision

The provision meets requirements

- Children's safety is given high priority because management implement rigorous policies and procedures for safeguarding children and keep the premises safe and secure. Staff have appropriate knowledge of the policies and procedures in relation to child protection and management and ensure these are followed.
- Robust recruitment procedures are in place to ensure staff working with children are suitable to do so. Staff understand the need to report any concerns they may have about a child's welfare and are clear about the procedures to be followed to protect children. Management have suitable monitoring in place to ensure continued suitability of staff.
- Staff have recently received specific training in how to manage behaviour; specifically in relation to children with special educational needs and/or disabilities.
- Children are well supervised and management ensures that the appropriate adult to child ratios are appropriately maintained at all times.
- Staff demonstrate a sound awareness of the Early Years Foundation Stage and use the framework to guide the observation, assessment and planning process. Staff are aware of the importance of good partnerships with parents, other providers and local support agencies.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector spoke with the club manager and children's care manager at length
 during the inspection and examined documentation covering children's records, policies and procedures, including medication procedures and accident forms.
- The inspector carried out a safety check on the parts of the premises used by the club and examined the club's risk assessments.
- The inspector checked evidence of suitability and qualifications of staff, the provider's self-evaluation form and improvement plan.

Information about the setting

Smiling Stars Out of School Club was registered in 2001 on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. It is situated in the ASRA building in the Smethwick area of the West Midlands and is managed by the Sandwell Asian Family Support Service. The club serves the local area and provides out of school care for children with special educational needs and/or disabilities only. Children can be referred to the club by Social Services, Children with Disabilities team, other professionals and parents. The club employs eight members of childcare staff. Of these, four hold an appropriate early years qualification at level 2 and three at level 3. The club is open Tuesday and Thursday evenings from 3pm to 6pm and on Saturdays from 11.30am to 3.30pm. The club also operates in the school holidays depending on funding, on Tuesdays, Thursdays and Fridays, from 10am to 2pm. Children attend for a variety of sessions. There are no children on roll in the early years age range. It supports children who speak English as an additional language. The club receives support from the Special Needs Advisory Service of the local authority. It also holds the 'Mencap Me 2' award for inclusive play settings.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
