Monitoring for provision judged as inadequate

An Ofsted inspector, Elizabeth Coffey, monitored your provision on 02/04/2014 following your inspection where the provision was judged to be inadequate.

Outcome of monitoring

As a result of our inspection on 17/01/2014, we sent you a welfare requirements notice. The actions you were set are included at the end of this letter.

The welfare notice required you to assess the risk to children's safety and identify how the risk will be removed or minimised; this is with particular regard to the looped cords attached to the blinds on the two sets of doors situated in the playroom and to ensure that all staff are fully trained to understand the safeguarding policy and procedures, and ensure that all staff have an up to date knowledge of safeguarding issues.

In addition we sent you a notice to improve that asked you to ensure the premises and equipment used for the purposes of childcare are safe and suitable for that childcare and to implement a written statement of procedures to be followed for the protection of children, intended to safeguard the children being cared for from abuse or neglect.

At the monitoring visit on 02 April 2014 the regulatory inspector found, through observation, discussion and documentation that you have met the actions that were raised within the timescales. The action that you have taken shows that you are making satisfactory progress overall. This is because, you had carried out and recorded a full risk assessment of the areas used by the after school club made various improvements to minimise reduce or remove risks, for example having the cords on the door blinds removed to prevent them posing a choking hazard to children. Children's safety across the school that you operate from was further improved as a risk assessment of cords on all blinds was carried out and they were either removed or fitted with safety clasps. You also record a weekly risk assessment

that identifies hazards and what action you and your staff have taken to minimise risk of injury or harm. For example you have recorded incidents when you have arrived to set up the afterschool club and found tables have been left out with remains of food from school dinners, which you and your staff have cleaned to ensure the health and safety of children.

You and your staff were able to demonstrate an increased knowledge and understanding of safeguarding practice and have now all completed safeguarding training. You have a written safeguarding policy in place. Details of the designated safeguarding officer are displayed on the parents notice board. Staff are able to identify possible causes for concern and were clear about their responsibilities in protecting children and lines of reporting any safeguarding matters. Staff also demonstrate a sound knowledge of whistleblowing and are clear that the interests of children would come first in the event of any concern they had about the conduct or actions of others.

The children in the after-school club were observed to be appropriately engaged in play and all appeared settled in the environment and at ease with the staff and each other. There was a range of activities available for the children to choose from, including art and craft activities, an activity bathing dolls, football and skipping. Tea time was noted to be a sociable event where the children chatted about their day and eagerly tucked into the warm pumpkin soup on offer. Samples of children's art work from previous sessions were on show. These included a display "All about Me" which included drawings, stories poems about the different parts of the world that children's families originated from.

You are a small team of three. You act as the manager and hold a relevant level 3 qualification. However your deputy does not hold a relevant qualification to allow her to take charge in your absence. Furthermore, there is no other member of staff who holds a level 3 qualification. This means that in the requirements of registration are not met in relation to staff qualifications and staff: child ratios, in the event of you being absent from the afterschool club at any time.

It was agreed that a notice to improve will be raised to ensure the requirements of registration are met. In order to meet the requirements of registration you must take the following action: ensure there is a named deputy, who in your judgement, is capable and qualified to take charge in your absence; and ensure that at least one member of staff holds a full and relevant level 3 qualification. Further monitoring is required to ensure the actions set at this visit are met and to ensure the setting can sustain the improvements already made.

Having considered all the evidence, the inspector is of the opinion that the setting has not taken prompt and effective action to address the points for improvement.
