Service information

Brief description of the service

The service provides short breaks for up to five young people with learning difficulties, sensory impairment or physical disabilities. It is provided by a local registered charity.

The inspection judgements and what they mean

Progress

Since their previous inspection the service is judged to be making **good progress**.

At the last inspection in August 2013 the overall quality rating for the service was good. Two requirements were made and have been met. The home has made good progress.

The home provides short breaks for children. No children were in the home at the time of the interim inspection. Staff are very supportive and provide individualised care. Parents report that children look forward to their short break and are provided with good support to help them to choose activities that they enjoy. They are well-supported to develop skills such as social skills and this is increasing their self-confidence and helps them to engage and to form friendships. Children are also encouraged to attend to their own personal needs and this maximises their independence.

A new manager has been appointed and has submitted an application to be the home's Registered Manager. The home also benefits from a competent deputy manager, who has provided good support to staff during the previous manager's period of absence.

Young people's files are now appropriately completed with the necessary information including their legal status; this promotes clear accountability. Quality assurance reports are now comprehensive and report on aspects of care to identify strengths and concerns in the service. Action is taken to address any shortfalls.

Parents report that they trust the home and know that their children are safe. They say that there is good on-going communication with staff about the activities that children have been engaged in. In addition, staff keep them well informed of any incidents that have occurred during the stay.

The home shows some flexibility in when they provide a break for children. Parents state that this has proved helpful when an unplanned event such as illness that hinders their capacity to care for their child takes place at home. The home is well cared for and bedrooms are homely.

The home rarely uses physical interventions however the log book does not ask staff to include all necessary information such as a debrief for the child. This reduces the amount of information available for evaluation. These events are discussed in regular staff supervision and staff meetings that are child-focused. Staff state that they feel very well supported. This shortfall has had no impact on children.
