The quality and standards of the early years provision

The provision meets requirements

- Staff have a good knowledge of the learning and development requirements and fully understand how to plan for individual children's interests, developmental needs and next steps. Staff fully understand the importance of completing observations to assess children's progress and of working in partnership with parents and other providers to build up a holistic view of children's development.
- Staff are very confident in discussing the possible indicators of abuse or neglect and the manager has a good knowledge and understanding of the procedures for referring any concerns about a child's welfare, in line with the Local Safeguarding Children Board. All staff fully understand their responsibility to provide a safe and secure environment for children to protect them from harm.
- The manager has a good understanding of her role and responsibilities as a leader and mentor for staff. She fully understands the importance of promoting an inclusive approach to monitoring and evaluating the service, so the views of all users are known and can be responded to. Plans for future improvement are clear and well-targeted.
- The areas of the premises used for the care of children are welcoming. The manager shows a good understanding of the importance of ensuring the environment provides challenge for children and to engage their interest, allowing them to be quiet or active according to their needs. Resources are varied and of good quality.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector had a tour of the premises and viewed all areas that are used when caring for children.
- The inspector met with the manager.
- The inspector discussed with the manager and staff how they intend to deliver the educational programmes for children.
- The inspector looked at a selection of policies, documents and examples of children's learning records.
- The inspector discussed with the manager the arrangements for self-evaluation and the setting's improvement plan.

Full report

Information about the setting

Driffield Out of School Club registered in 1995 on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. It is run by East Riding of Yorkshire Council and operates from the leisure centre, which is on the site of Driffield Secondary School in the centre of Driffield in East Yorkshire. It has use of the multifunction room on the first floor, the sports hall on the ground floor, the school grounds and the all-weather surface courts for outdoor play. There is lift access to the first floor. The club employs five core members of childcare staff. Of these, four hold appropriate early years qualifications at level 3 and one holds a qualification at level 2. The club is open to all children and operates from 3.30pm to 6pm, Monday to Friday during term time and from 8am to 6pm, Monday to Friday, during school holidays. There are currently 116 children on roll, eight of whom are in the early years age group and attend for a variety of sessions. The club receives support from the local authority and is a member of the 4 Children organisation. There were no children present in the early years age group at the time of the inspection.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
