Service information

Brief description of the service

The home can accommodate up to eight young people with emotional and/or behaviour difficulties. The home is run by the local authority.

The inspection judgements and what they mean

Progress

Since their previous inspection the service is judged to be making **satisfactory progress**.

At the last inspection in January 2014 the overall quality rating for the service was judged as good. Two requirements were made regarding the wedging open of doors and the management of medication. Both requirements have been addressed. This reflects the staff team's desire and commitment to improve the quality of care provided. However, the judgement of satisfactory progress has been given due to a number of shortfalls.

Staff are now clear that doors must not be wedged open. This was discussed at a staff meeting to ensure all staff are aware of their responsibilities in this area. The Registered Manager has consulted with the Fire Officer on this matter. The home has ordered magnetic retainers which will be fitted to the office door and all bedroom doors. These measures help to protect young people and staff from the risk of harm.

Improvements have been made to the management of medication since the last inspection. A new medication policy has been produced and staff have received refresher training; this includes the management of medication errors. A new medication dispensing station is also on order which will mean there is a dedicated area for the administration and recording of medication. A review of medication records by the inspector identified that practices were in line with procedures. As a result of these improvements, young people's health needs are being met and they are protected from the risk of harm.

Young people continue to make good progress given their starting points. They remain happy and settled in the home. This is because their relationships with staff are open and honest which enables young people to trust and have confidence in staff. Young people continue to be central to decision-making in their lives and in the running of the home; this increases their confidence and helps them to feel valued. Young people continue to make good progress in their education and in gaining access to training and employment. This is because staff are committed to supporting young people to improve their life opportunities.

New young people are made very welcome when they are admitted to the home. Staff spend time with them and explain the rules, routines and relevant procedures such as fire safety and the complaints procedures. This helps young people to settle quickly.

Young people continue to receive individualised support based on their needs. They are supported to access different services to ensure their holistic health needs are being met including psychological and emotional needs. However, the inspector identified a shortfall in recruitment practices which has the potential to place young people at risk of harm. The home does not have documentary evidence of recruitment checks for professionals who are commissioned to work with young people at the home but are not employed by the organisation.

Staff continue to work closely with the relevant agencies including the police where there are safeguarding issues. This helps to protect young people from the risk of harm and abuse. Records reflect this collaborative working. However, young people's placement plans and risk assessments are not always updated promptly when there has been a safeguarding incident. This has the potential to affect the ability of staff to meet all young people's needs and protect them from the risk of harm and abuse. Additionally, there is no documentary evidence to demonstrate that compatibility assessments have taken place regarding the existing group and new young people admitted to the home. This includes assessing the potential risks posed by some young people's behaviour. This makes it difficult to assess how all individual's needs have been assessed in terms of compatibility and how young people are protected.

Since the last inspection some young people have moved out of the home into supported living and foster care. These were positive moves for the individuals and reflect the progress they have made whilst living at the home. It also demonstrates that young people's views about their future were listened to and acted upon.

The promotion of independence continues to be at the forefront of practice and support and advice provided to young people takes into account risk management. Young people learn to take controlled risks in a nurturing environment in preparation for adulthood and their next stages of life. As a result, they increase their daily living skills and their safety improves as they learn to take responsibility for their actions.
