The quality and standards of the early years provision

The provision meets requirements

- The childminder has a good knowledge of the prime and specific areas of learning and of how to challenge children in their learning and development. Through discussion, she demonstrates a good understanding of how to engage with children and how to monitor their development. Documents show how she has measured children's progress and recorded past observations of children at play.
- The childminder understands how children develop and learn. Through discussion, she demonstrates that she has good knowledge of how to support children's learning, through a variety of child-initiated and structured activities. The childminder is confident in discussing how to engage parents within their child's early education.
- The childminder gives examples of how she would plan appropriate and stimulating activities across the seven areas of learning. The childminder fully understands how to create a safe and secure child-centred environment for indoor and outdoor play. Resources are of good quality. The childminder understands how to encourage children to learn to manage risk in a safe and supportive way.
- The childminder is enthusiastic and committed to providing a good quality service. She is well organised and maintains comprehensive documentation to support her practice. The childminder has clear knowledge and understanding of child protection issues and how to deal with any concerns.
- The childminder has good knowledge of how to share information with parents about their child's day, progress and achievements. The childminder monitors and evaluates her provision effectively with the support of other early years providers with whom she shares ideas and best practice.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector undertook a tour of the premises and the areas available for childminding, including the outdoor space.
- The inspector looked at a range of documents, including the self-evaluation form, policies, procedures and past records.
- The inspector spoke with the childminder during the course of the inspection.

Information about the setting

The childminder was registered in 2013 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her three children aged six, eight and 10 years in a house in Coventry. The whole of the ground floor and the rear garden are used for childminding. The childminder attends a toddler groups and activities at the local library. She visits the shops and local parks on a regular basis. There are currently no children on roll within the early years age group. However, children can attend for a variety of sessions. She operates all year round from 6am to 7pm, Monday to Saturday, except bank holidays and family holidays. She is a member of Professional Association for Childcare and Early Years.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
