#### The quality and standards of the early years provision

#### The provision meets requirements

- Leadership and management are effective as the provider fully understands their responsibilities in meeting the safeguarding and welfare requirements of the Early Years Foundation Stage. All the required documents, policies and procedures to ensure the smooth efficient running of the service are maintained and available for inspection.
- The provider maintains a sound knowledge of the Local Safeguarding Children Board procedures. Suitable steps are in place to assess the risks or hazards, which may arise in the setting and when on outings so as to protect children.
- All relevant consents and information are obtained from parents. This demonstrates the providers commitment to keep children safe and protected from harm.
- The provider promotes the children's safety and well-being as she ensures that there is always a qualified first aider present on the premises and on outings. Records of any accidents that occur are recorded and shared with parents. All accident records are monitored by the provider to establish if any patterns are emerging.
- The provider organises the premises to enable children to select activities that suit their interest or moods. This means children can be energetic, restful or creative as and when they wish without compromising the enjoyment of their peers.
- The provider has a suitable knowledge of the learning and development requirements. An ability to observe, assess and plan suitable experiences and outings for the children cared for is demonstrated. These activities provide familiar and different experiences typical for the expected developmental stages of the children attending.
- The provider demonstrates a commitment to working with parents and other providers and services to complement children's learning needs.

## Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

#### Information about the setting

Cornerstone Holiday Club was registered in 2013 and is operated by a company. It is based in the Cornerstone Centre which is situated in the West Derby area of Liverpool. Children are cared for on the ground floor of the premises and there is an area that can be secured to allow for outdoor play. The setting is open each weekday from 8am to 6pm during holiday times only and provides care for children aged four years and over. Children attend for a variety of sessions. The setting employs four members of childcare staff, of who three hold appropriate childcare qualifications. These include one member of staff who has a qualification at level 4 and two members of staff who have a qualification at level 3. One member is working towards a qualification. The setting is a member of the National Day Nursery Association. It is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register.

# Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
