The quality and standards of the early years provision

The provision meets requirements

- The inspection took place following a notification to Ofsted that a child's medication had not been administered correctly. The nursery quickly made arrangements to seek professional health advice. The manager has now reviewed and updated the medication policy to include clear procedures for the purpose of ensuring there is always a witness present when children's medication is administered.
- The nursery has a clear child protection and safeguarding policy in place. The manager takes responsibility for ensuring staff are kept up to date with child protection issues. The manager conducts daily risk assessments so the premises are safe and secure for children.
- The manager makes expectations of behaviour clear to children, giving reasons for requests to help ensure they understand why behaviour is unacceptable. She reports children's behaviour is managed through distraction, simple explanation and helping them resolve conflicts. Any inconsistencies in practice are dealt with through closely monitoring staff's ongoing suitability and training.
- Staff make regular observations to monitor children's progress and identify the next steps in their learning to help them move on in their development, supporting children's learning and helping them make progress from their starting points. Staff work in partnership with parents and other agencies to help ensure they meet all children's individual needs.
- The nursery demonstrates sufficient capacity to continuously improve the outcomes for children through the self-assessment process and training.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

The inspector sampled a range of documents that includes staff records,

- qualification and training certificates, policies, risk assessment record and children's assessments records.

Information about the setting

Bowlers Community Nursery registered in 1994 and is run by a management committee of parents. It is housed in self-contained premises within the grounds of the redevelopment of Crouch Hill Park, which is located in Crouch Hill in the London Borough of Islington. There are two rooms; one of which is an open-planned designed room and separate baby room.

There is an enclosed landscaped garden for outdoor play. The nursery is open each week day from 8.30am to 5.30pm, for 49 weeks of the year. The nursery offers sessions, daily and weekly, to meet the needs of the parents.

The nursery is registered on the Early Years Register and both the compulsory and voluntary parts of the Childcare Register. There are currently 34 children aged from one year to under five years on roll. The nursery is funded to provide free early education to children aged three and four years. There were no children present at the time of the inspection.

There are eight staff members working directly with the children. All staff members hold early years qualifications. This includes the manager who holds a degree in Early Childhood Studies and has Early Years Professional Status. Another member of staff holds a degree in Early Childhood Studies. Additional support staff are also employed including a chef and a finance administrator.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
