The quality and standards of the early years provision

The provision does not meet requirements

- The inspection took place following concerns raised to Ofsted relating to obtaining important information about the child before caring for them, providing parents with information, the range of meals on offer and the resources available to children.
- The childminder demonstrates a sound understanding of safeguarding procedures and keeping children's safe in the home. She has attended recent training courses in childcare practice to help to improve outcomes for children.
- The childminder explained how she will provide age and stage activities and resources to meet children's developmental needs. There is an adequate range of resources available that are easily accessible to help promote children's learning and development.
- The childminder explains how she offers children a good range of nutritious meals and drinks to suitably promote children's healthy lifestyles.
- The childminder discussed how she works with parents and shares information about the child's progress. However, she does not obtain required information about children before they start attending to meet their welfare needs adequately. This is a breach of requirements for the Early Years Register and the Childcare Register.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector had discussions with the childminder to ascertain her knowledge of safeguarding children and promoting their welfare.
- The inspector looked at the areas of the home the childminder will use for minding children.
- The inspector discussed the required documentation with the childminder

Information about the setting

The childminder registered in 1993. She lives with her husband and one adult child in a house in Leytonstone, in the London Borough of Waltham Forest, within easy walking distance of shops, parks, nurseries and schools. The whole of the ground floor is used for childminding. There is a fully enclosed garden for outside play. The childminder is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. There are currently no children on roll.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage the provider must:

- obtain and record the following information for each child at the point of registration: full name; date of birth; name and address of every parent and/or carer who is known to the provider (and information about any other person who has parental responsibility for the child); which parent(s) and/or carer(s) the child normally lives with; and emergency contact details for parents and/or carers.

- obtain and keep records of the following and retain them for a period of two years: the name, home address and date of birth of each child who is looked after on the premises; and the name, home address and telephone number of a parent/guardian/carers of each child who is looked after on the premises (voluntary part of the Childcare Register).

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
