### The quality and standards of the early years provision

#### The provision does not meet requirements

- The manager is suitably qualified and staff attend a variety of courses to refresh their knowledge and practice. For example, first aid and food safety training. Although the deputy is working towards a qualification, she is not yet qualified to a suitable level in order to be able to take charge in the absence of the manager. This is a breach of the safeguarding and welfare requirements.
- There is a sound safeguarding policy in place, however, this does not include the procedure for the use of mobile phones and cameras. Staff have sufficient knowledge of the signs and symptoms of abuse and would confidently take action should there be any concerns about a child's welfare.
- Despite being checked by Ofsted, a list of Disclosure and Barring Service checks on staff were not available for the inspector to view. However, staff are recruited and vetted appropriately. This includes checks completed by Ofsted and references.
- Through documentation and discussion, the provider demonstrates that the learning and development requirements are met. Children's files are developed to ensure the seven areas of learning are observed and documentation to plan for children's interest is in place.
- The provider values partnerships with parents and other professionals. They understand the importance of working together with others who care for children to meet their individual needs.
- There are a range of resources available that are accessible to children both indoors and out. The range covers all areas of learning. Risk assessments are in place for the areas of play, demonstrating the provider's knowledge of how to keep children safe.

### Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

### **Inspection activities**

- The inspector observed activities in the club and talked with the staff.
- The inspector viewed the building and grounds of the school used for out of school care.
- The inspector looked at children's assessment records, planning documentation and a range of other documentation, including the safeguarding procedures.
- The inspector took account of the views of parents and children as spoken to on the day.

### Information about the setting

Elsworth Happy Faces was registered in 2013 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. The club is situated in a separate building on the grounds of Elsworth Primary School, Elsworth, Cambridgeshire. The club is managed privately. The club serves the local area and is accessible to all children. Children have access to an outdoor play area. The club opens Monday to Friday, school term times only. Sessions are from 8am until 8.55am and 3pm until 6pm. Children attend for a variety of sessions. There are currently 40 children attending aged between four and 11 years, eight of whom are in the early years age group. However, no children in the early years range were present at the time of inspection. The club employs two members of childcare staff. Of these, one holds an appropriate early years qualification at Level 3.

### What the setting needs to do to improve further

# To meet the requirements of the Early Years Foundation Stage the provider must:

- ensure the named deputy is suitably qualified to be able to supervise the club in the manager's absence and to ensure qualification ratios are met at all times
- ensure the safeguarding policy covers the use of mobile phones and cameras in the club
- ensure details of the suitability of all staff are available to view for inspection, this refers to Disclosure and Barring Services information.

### Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages.
